# MoneyHero x WeLab 私人貸款條款及細則 – 202505優惠(須提取貸款) (「推廣活動」)

## 202505 MoneyHero x WeLab Personal Loan - Drawdown Offer

1.新客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞 (定義見下文)。

iv. Loan amount from HK\$500,001 to HK\$600,000 + repayment period 24 months or above:

- HK\$3,000 Apple Store Gift Card; OR
- HK\$3,000 Wellcome Shopping Voucher.

v. Loan amount from HK\$300,001 to HK\$500,000 + repayment period 24 months or above:

- HK\$2,000 Apple Store Gift Card; OR
- HK\$2,000 Wellcome Shopping Voucher.

vi. Loan amount from HK\$200,001 to HK\$300,000 + repayment period 24 months or above:

- HK\$1,000 Apple Store Gift Card; OR
- HK\$1,000 Wellcome Shopping Voucher.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero.
