

# MoneyHero x 邦民日本財務私人貸款條款及細則 – 2024/09/30 - 2024/11/29 6pm (須提取HK\$10,000或以上貸款額) (「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並成功提取HK\$10,000或以上貸款額，以及完成以下要求的合資格客戶，將獲得推廣獎賞（定義見下文）。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為2024/09/30至2024/11/29 6pm，包括首尾兩日（「推廣期」）。

## 3. 就此推廣活動而言：

- a. 「指定貸款」指邦民特快私人貸款及邦民特快低息貸款（適合稅季）及邦民低息結餘轉戶貸款。
- b. 「貸款提供者」指邦民日本財務。

## 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的邦民日本財務之合資格全新客戶；
- b. 在推廣期內通過MoneyHero使用指定鏈接完整填寫並提交指定貸款的申請；
- c. 提交指定貸款的申請後7天內完整填寫並提交MoneyHero獎賞換領表格；
- d. 客戶需獲貸款提供者確認其貸款申請並成功提取HK\$10,000或以上貸款額。

## 5. 推廣獎賞及兌換

a. 完成第4條所列條件的合資格客戶將能選擇以下「推廣獎賞」之一，視供應情況而定：

- i. HK\$500惠康禮券；或
- ii. HK\$500HKTVMall 電子購物禮券；

## Terms and Conditions of MoneyHero x Promise Personal Loan –2024/09/30 - 2024/11/29 6pm (Drawdown of HK\$10,000 or above is required) (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete drawdown of HK\$10,000 or above plus the other requirements set out herein will receive a Promotion Reward (each as defined below).

### 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2024/09/30 to 2024/11/29 6pm both dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

a. “**Designated Loan**” means Promise Instant Personal Loan, Promise Instant Low Interest Loan (Suitable for tax), Promise low-interest Debt Consolidation Loan.

b. “**Product Provider**” means **Promise**.

### 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be an eligible new customer of Promise who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;

c. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after completing the application for a designated loan;

d. Have their application for the Designated Loan confirmed by the Product Provider and complete drawdown of HK\$10,000 or above.

- a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following **"Promotion Rewards"**, subject to availability:

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. - d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
