- v. 貸款額自 HK\$300,001 至 HK\$500,000 + 還款期 24 個月或以上:
  - HK\$2,000 Apple Store 禮品卡; 或
  - HK\$2,000 惠康購物現金券; 或
  - [現金獎賞] HK\$1,600現金 (直接存入FPS戶口).
- vi. 貸款額自 HK\$200,001 至 HK\$300,000 + 還款期 24 個月或以上:
  - HK\$1,000 Apple Store 禮品卡; 或
  - HK\$1,000 惠康購物現金券; 或
  - [現金獎賞] HK\$800現金 (直接存入FPS戶口).
- b. 合資格客戶將最多可獲得1個推廣獎賞。

  - ii. - d.   - iv. Loan amount from HK\$500,001 to HK\$600,000 + repayment period 24 months or above:

    - HK\$3,000 Wellcome Shopping Voucher; OR
    - HK\$2,400 (Deposited via FPS Account) ("Cash Reward").
  - v. Loan amount from HK\$300,001 to HK\$500,000 + repayment period 24 months or above:
    - HK\$2,000 Apple Store Gift Card; OR
    - HK\$2,000 Wellcome Shopping Voucher; OR
    - HK\$1,600 (Deposited via FPS Account) ("Cash Reward").
  - vi. Loan amount from HK\$200,001 to HK\$300,000 + repayment period 24 months or above:
    - HK\$1,000 Apple Store Gift Card; OR
    - HK\$1,000 Wellcome Shopping Voucher; OR
    - HK\$800 (Deposited via FPS Account) ("Cash Reward").
- b. Eligible Customers will receive a maximum of 1 Promotion Reward.
- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
