MoneyHero x 大新銀行私人貸款條款及細則 – 2024年12月申請獎勵(無須提取貸款) (「推廣活動」)

1.客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞(定義見下文)。

2. 推廣期

2. Promotion Period
