

(2025/05/07 12pm) MoneyHero x Webull

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞（各自定義如下）。

2. 推廣期
