

# MoneyHero X 星展銀行 星展豐盛理財戶口條款及細則 - Apple 禮品卡 / HKTVmall電子禮券/ DFS 禮券 / NESCAFÉ Dolce Gusto Genio S Plus 膠囊咖啡機連6盒膠囊/ De'Longhi 半自動咖啡機 EC685 (“推廣活動”) (2024年8月)

1. 新客戶在推廣期間透過 MoneyHero以指定推廣編號 經DBS digibank HK應用程式遞交網上開戶申請完成「手機開戶」或於網頁成功預約「分行開戶」，申請指定銀行賬戶，並獲批及完成本文所述其他要求的合資格客戶將會獲得推廣獎賞(各自定義如下)。

## 2. 推廣期間

除非另有規定，推廣活動的推廣期間為2024年8月21日中午12時至2024年9月30日下午6時(“推廣期間”)。

## 3. 本推廣活動的定義：

- a. “指定銀行賬戶”是指透過星展銀行申請的星展豐盛理財賬戶。
- b. “產品提供者”是指星展銀行。
- c. “新客戶”是指在申請參加本推廣活動的指定銀行賬戶之前的12個月內未持有任何星展銀行賬戶或信用卡賬戶或服務的全新星展客戶。
- d. “指定推廣碼”是指「DBSMH」。
- e. “手機開戶”是指透過 MoneyHero 網站，然後經DBS digibank HK應用程式開戶，並輸入指定推廣碼及正確個人資料，完成整個申請流程直至「完成登記 謝謝」頁面。
- f. “分行開戶”是指透過 MoneyHero 網站到DBS網站預約到分行開戶並與職員在開戶過程中使用指定推廣碼。

## 4. 合資格客戶

為了獲得推廣獎賞並成為“合資格客戶”，客戶需：

Terms and Conditions of MoneyHero DBS Treasure account - Apple Gift Card / HKTV Mall Voucher / DFS Voucher / De'Longhi Pump-driven Espresso Coffee Machine EC685/ NESCAFÉ Dolce Gusto Genio S Plus Coffee Machine with 6 Coffee Capsules(the "**Promotion**") (Aug 2024)

1. New customers who apply for a designated bank account through MoneyHero using the promotion code with the DBS Digibank HK app to complete "Mobile Account Opening" or successfully make an e-appointment for "Branch Account Opening" on the website. Eligible customers who meet the requirements mentioned and be approved will receive promotional rewards (each as defined below).

## 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 21 August 2024 (12nn) to 30 September 2024 (6pm), dates inclusive (the "**Promotion Period**").

3. For the purposes of this Promotion:

a. "**Designated Bank Account**" means the DBS Treasures Account.

b. "**Product Provider**" means **DBS Bank**.

c. "**New Customer**" means brand new DBS customers who have not maintained any bank account or credit card account or service with DBS within the 12 months prior to making their application for the Designated Bank Account as part of this Promotion.

d. **Promotion Code** means "DBSMH"

**e. Mobile App Account Opening** means opening an account through the MoneyHero website and download DBS digibank HK App, then entering the promotion code and personal information, finish the full application journey until the "Registration Completed, Thank You" page.

**f. E-appointment and account opening at branches** means making an e-appointment on the DBS website through MoneyHero, using the promotional code during the account opening process.

#### **4. Eligible Customers**

In order to receive a Promotion Reward and to comprise "**Eligible Customers**", customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider's website;
- c. Fully complete and submit an application for a Designated Bank Account through MoneyHero using the designated link and use the MoneyHero promo code "DBSMH" during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;
- e. Have their application for the Designated Bank Account approved by the Product Provider; and

#### **5. Promotion Rewards and Redemption**

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following "**Promotion Rewards**", subject to availability:

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e.
