

MoneyHero x WeLab 私人貸款條款及細則 – 2024年10月申請獎勵(無須提取貸款) (「推廣活動」)

(2024/08/01 12nn - 2024/10/31 6pm) MoneyHero x WeLab - Personal Loan - Application Incentive

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期

除非另有說明，推廣活動的推廣期為2024/08/01 12nn至2024/10/31 6pm，包括首尾兩日(「推廣期」)。

3. 就此推廣活動而言：

a. 「指定貸款」是指WeLab Bank 私人分期貸款及WeLab Bank 清卡數貸款及WeLab Bank私人分期貸款(公務員及專業人士)。

b. 「產品提供者」是指匯立銀行。

c. 「指定優惠碼」是 NLHERO。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- a. 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶；
- b. 最低年薪為HK\$120,000；
- c. 在被重定向至產品提供者網站之前，向MoneyHero提供有效的電郵地址；
- d. 在推廣期內通過MoneyHero使用指定優惠碼完整填寫並提交指定貸款的申請；
- e. 在收到MoneyHero獎賞換領表格後7天內完整填寫並提交MoneyHero獎賞換領表格。
- f. 客戶需同時向銀行交齊所有文件並獲銀行確認其貸款申請。

5. 推廣獎賞及兌換

a. 完成第4條所列條件的合資格客戶將能選擇以下「推廣獎賞」之一，視供應情況而定：

i. HK\$800惠康禮券；或ii. HK\$800Apple Store禮品卡；或iii. HK\$800 Trip.com 現金券。

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2024/08/01 12nn to 2024/10/31 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Loan**” means the **WeLab Bank Personal Instalment Loan and WeLab Bank Card Debt Consolidation Loan and WeLab Bank Personal Instalment Loan (For Civil Servants & Professionals)**.

b. “**Product Provider**” means WeLab Bank.

c. “**Promotion Code**” means “NLHERO”

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Minimum annual salary requirement is HK\$120,000 ;

c. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

d. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated promotion code during the Promotion Period; and

e. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero.

f. Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
