

MoneyHero x Mox「即時借」條款及細則 – 2024年10月提取貸款優惠(「推廣」)

1. 新客戶凡在推廣期內通過MoneyHero指定優惠碼成功開立指定戶口，並申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，

「指定優惠碼:MHOCT」適用於2024年9月30日至2024年10月31日晚上23時59分(「推廣期間」)。

3. 推廣條款

a. 「指定貸款」指Mox「即時借」。

b. 「產品提供者」指Mox Bank。

c. 「指定優惠碼」為「MHOCTY」, (「指定優惠碼」)

d. 「新客戶」指指在使用邀請碼開立你的 Mox 戶口前 12 個月的任何時間, 你沒有以你的名義持有 Mox 戶口。儘管你未曾使用你舊有的 Mox 戶口進行任何交易, 你亦會被視為持有 Mox 戶口。

e. 「指定戶口」指Mox戶口。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」, 客戶需:

a. 為18歲或以上, 持有有效香港身份證且在香港有通訊地址的新客戶;

Terms and Conditions of MoneyHero x Mox Instant Loan – October 2024 Drawdown offer (the “Promotion”)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero with designated promo code during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the “Designated promo code ” is from 2024/09/3 to 2024/10/31 dates inclusive (the “Promotion Period”).

3. For the purposes of this Promotion:

a. “Designated Loan” means the Mox Instant Loan;

b. “Product Provider” means Mox Bank;

c. “Designated promo code” means MHOCT ; (the ‘Designated promo code’)

d. “New customer” means customers who have not held a Mox Account in your name at any time in the 12-month prior to your Joining Day. You are considered to have held a Mox Account even if you haven’t completed any transactions on your prior Mox Account;

e. “Designated Account” means Mox Bank Account.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “Eligible Customers”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Fully complete and successfully apply for a Designated Loan within 60 days after successfully open the designated account via through MoneyHero designated promo code within the promotion period, with tenor 12 months or above and with loan amount HK\$100,000 or above. An email from Mox Bank will be issued within 30 working days, containing an application reference number (7 alpha-numeric digits) to the email address registered with Mox Bank.

d. Fully complete and submit the [MoneyHero Reward Redemption Form](#) within 14 days after receiving the Mox Bank email;

5. Promotion Rewards and Redemption

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
