

# MoneyHero x 信銀國際私人貸款條款及細則— 2024年12月申請獎勵(無須提取貸款) (「推廣活動」)

(2024/10/31 12nn - 2024/12/31 6pm) MoneyHero x Citic - Personal Loan - Application Incentive

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

## 2. 推廣期

除非另有說明，推廣活動的推廣期為2024/10/31 12nn至2024/12/31 6pm，包括首尾兩日(「推廣期」)。

3. 就此推廣活動而言：

a. 「指定貸款」是指信銀國際 \$mart Plus 分期貸款 (稅季優惠)及信銀國際 \$mart Plus 分期貸款 - 結餘轉戶。

b. 「產品提供者」是指信銀國際。

## 4. 合資格客戶

Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
