MoneyHero x 富邦「卡數清」私人貸款條款及細則 – 2024/10/15 - 2025/1/3 6pm 申請獎勵(無須提取貸款) (「推廣 活動」)

MoneyHero x Fubon Balance Transfer Personal Loan - Application Incentive

1.客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞(定義見下文)。

2. 推廣期
