

(2025/03/11 6pm) MoneyHero x Citi_Core Card

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

2. 推廣期

除非另有說明, 推廣期為2025/03/11 6pm至 2025/03/14 6pm(包括首尾兩天) (“推廣期”)。

3. 推廣活動相關定義

- a. “指定信用卡”指Citi Cash Back 信用卡或Citi Rewards 銀聯信用卡或Citi PremierMiles 信用卡或Citi Rewards 信用卡。
- b. “信用卡提供者”指花旗銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有花旗銀行任何信用卡的客戶。
- d. “合資格簽賬”指HKD\$4000。

4. 合資格客戶條件

b. 合資格客戶最多可獲得 1 項推廣獎賞。

c. 確認合資格後, 兌換詳情將通過電子郵件發送到合資格客戶提供給 MoneyHero 的電子郵件地址。MoneyHero 有絕對酌情權決定的情況下, 提供不準確或不正確信息的合資格客戶將無法獲得任何推廣獎賞。

b. “**Product Provider**” means **Citi Bank**.

c. “**New Customer**” means customers who have not held any credit card with Citi Bank in the 12 months preceding the date on which their application for a Designated Card is made as part of this Promotion.

d. “**Eligible Spending**” means HKD\$4000

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2025/05/01, subject to the Product Provider’s system records.

*The above gifts i - v are limited to a total of 500 slots, with limited quantities available on a first-come, first-served basis.. The excess quotas will be compensated with a HK\$1,800 Wellcome supermarket gift voucher as a substitute gift.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
