1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

2. 推廣期

除非另有說明, 推廣期為2024/11/30 18:00至 2024/12/16 10:00(包括首尾兩天) (“推廣期”)。

4. 合資格客戶條件

4. Eligible Customers

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and

i. Apple Store Gift Card, value of HK\$400; or ii. Wellcome supermarket voucher, value of HK\$400; or iii. Trip.com Gift voucher, value of HK\$400; or iv. BRUNO BAK802 Hot Soup Blender(random color), value of HK\$698; or v. Marshall Willen Portable Bluetooth speaker, value of HK\$999.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
