

【MoneyHero 佛系 x 生活 - 送Nintendo Switch 2 主機組合或其他豐富禮品】(「推廣活動」)條款及細則

1. MoneyHero Global Limited (「MoneyHero」) 為本次推廣活動 (「本推廣」) 的主辦方。根據本推廣條款, 符合資格的參加者於 MoneyHero 網站成功申請指定產品並參與本推廣, 即有機會獲得獎品 (定義見下文)。

2. 推廣活動時間

除特別註明外, 此次推廣期由2025年4月28日下午6點活動開始至2025年5月23日下午11時59分, 包括首尾兩日。

3. 參加資格

參加本推廣並成為「合資格參加者」, 參加者必須符合以下條件:

- a. 持有有效的香港身份證, 並為年滿18歲或以上的香港居民;
- b. 於推廣期內, 透過 MoneyHero 申請或投保 (詳見以下第4條) 合資格產品;
- c. 於推廣期內:
 - i. 申請信用卡: 須為每項申請的合資格產品完整填妥並提交 MoneyHero 獎賞換領表格;

5. 活動規則

合資格參加者須透過指定的 MoneyHero 推廣網頁提交比賽問題答案。此比賽為技巧遊戲，非靠機會或運氣決定。

- 答案必須以中文提交，且不得超過100字。
- MoneyHero 評審團將審核參賽作品，於推廣期內每週選出一百五十八(158)個最具創意的合資格參加者答案作為比賽得獎者(「得獎者」)。含有不道德、淫穢或冒犯性內容的提交(由 MoneyHero 全權決定)將不予考慮。評審團會根據答案的創意程度對得獎者進行排名(每週1至158名)。
- 推廣期為四週，總共選出六百三十二(632)名得獎者。
- 評審團的決定為最終決定，且不可提出異議。評審團無須就決定提供具體解釋，亦不會就決定進行任何對話或通信。

5. Competition Rules

Eligible Participants must submit answers to the competition question via the designated MoneyHero Promotion webpage. The competition is a game of skill, not chance or luck.

- Answers must be in Chinese and not exceed 100 characters.
- The MoneyHero judging panel will review submissions and select the one hundred fifty-eight (158) most creative answers submitted by Eligible Participants

each week during the Promotion Period as competition winners ("**Winners**"). Submissions containing immoral, obscene, or offensive content (as determined solely by MoneyHero) will not be considered. The judging panel will rank Winners (1-158 per week) based on the creativity of their answers.

- c. The Promotion Period spans four weeks, with a total of six hundred thirty-two (632) Winners selected.
- d. The judging panel's decisions are final and not subject to appeal. The panel is not obliged to provide specific explanations for its decisions or engage in any dialogue or correspondence regarding its decisions.

- f.
