

(2025/01/02 12pm) MoneyHero x Standard Chartered -Smart Card

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2025/01/02 12pm至2025/02/03 12pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

a.«指定信用卡»是指渣打銀行(香港)有限公司發行的渣打Smart信用卡。

b.«信用卡提供者»是指渣打銀行(香港)有限公司。

c.«新客戶»是指在推廣期前6個月內未持有或取消任何渣打銀行(香港)有限公司發行的主卡渣打信用卡或 MANHATTAN 信用卡的客戶。

4. 合資格客戶

為獲得推廣獎賞並成為«合資格客戶», 客戶需:

5. 推廣獎賞及兌換

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/01/02 12pm to 2025/02/03 12pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Card**” means the Standard Chartered Smart Credit Card.

b. “**Product Provider**” means Standard Chartered Bank (Hong Kong) Limited.

c. “**New Customer**” means customers who do not currently hold and have not cancelled any principal card of Standard Chartered Credit Card or MANHATTAN Credit Card issued by Standard Chartered Bank (Hong Kong) Limited in the 6 months prior to the date of approval of their current application for a Designated Card as part of this Promotion.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

e. Have their application for the Designated Card approved by the Product Provider on or before 2025/03/03, subject to the Product Provider’s system records; and

f. Submit (i) the name of the Designated Card applied for, (ii) their application date, and (iii) a screen capture of the approval SMS or email notification to support@moneyhero.com.hk within 7 days of receiving approval from the Product Provider, which will be used by MoneyHero to verify reward eligibility.

5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

BRUNO Compact Hot Plate, value of HK\$998; or vi. Marshall EMBERTON II bluetooth speaker, value of HK\$1,499; (random color).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers’ internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e.
