

## MoneyHero x 富途證券 HK 條款及細則 (以下稱「推廣活動」) (2025年1月)

1. 於推廣期內, 透過MoneyHero申請指定帳戶, 並獲批准且完成此處列明的其他要求的合資格客戶, 將獲得推廣獎賞(各自定義如下)。

### 2. 推廣期

除非另有說明, 推廣活動的推廣期為2025年1月3日(下午6點)至2025年2月3日(下午6點), 包括首尾兩日(以下稱「推廣期」)。

### 3. 本推廣活動而言:

- a. 「指定帳戶」是指富途證券戶口。
- b. 「產品供應商」是指富途證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立富途證券帳戶的用戶。

### 4. 合資格客戶

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

- a. 成為年滿18歲或以上, 持有有效香港身份證並擁有香港通訊地址的新客戶;
- b. 在被重定向至產品供應商網站之前, 向MoneyHero提供有效的電郵地址;
- c. 在推廣期內, 透過MoneyHero使用指定連結完整填寫並提交指定帳戶的申請;
- d. 在收到MoneyHero獎賞兌換表格後的7天內(無論如何不得遲於2025年2月10日)完整填寫並提交MoneyHero獎賞兌換表格, 包括在MoneyHero獎賞兌換表格的「申請參考號碼」部分提供其Futu帳戶ID(8位數字);
- e. 其指定帳戶的申請需獲產品供應商批准, 並在2025年2月3日(下午6點)或之前完成開戶手續, 根據產品供應商的系統記錄;及
- f. 為獲得某些推廣獎賞, 需在指定帳戶中存入至少HK\$10,000並保持至少60天。

### 5. 推廣獎賞及兌換

- a. 完成上述第4條規定條件的合資格客戶, 根據所達成的條件(視供應情況而定), 可選擇以下「推廣獎賞」之一:

- b. 合資格客戶將最多獲得1個推廣獎賞。
- c. 為免產生疑問, 成為「合資格客戶」只需向指定帳戶注入指定金額, 無需訂閱或購買任何證券、投資產品及/或進行任何證券或投資產品的交易或交易。
- d. 經確認資格後, 兌換指示將通過電子郵件發送至合資格客戶在MoneyHero提供的電郵地址。提供不準確或錯誤信息的合資格客戶(由MoneyHero自行全權決定)將無法獲得任何推廣獎賞。

## Terms and Conditions of MoneyHero x Futu HK (the “**Promotion**”) (Jan 2024)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

### 2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 3 Jan 2025 (6pm) to 3 Feb 2025 (6pm), dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Account**” means the Futu Securities Account.

b. “**Product Provider**” means Futu.

c. “**New Customer**” means Customers who have not opened a Futu Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

### 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero (and in any event no later than 10 Feb 2025), including providing their Futu Account ID (8 digits) in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;

e. Have their application for the Designated Account approved by the Product Provider and complete the account opening procedure on or before 3 Feb 2024(6pm), according to the Product Provider’s system records; and

f. In order to receive certain Promotion Rewards, deposit at least HK\$10,000 into the Designated Account and maintain the same for at least 60 days.

### 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, depending on the criteria fulfilled, subject to availability:

If you successfully open a Designated Account and deposit at least HK\$10,000 into the Designated Account and maintain the same for at least 60 days, maintain daily average assets of HK\$10,000 or above, you can get a Apple Store Gift Card, value of HK\$1,000; OR a HKTVmall electronic Voucher, value of HK\$1,000 ; OR Wellcome Shopping Voucher, value of HK\$1,000; OR Futu Cash Voucher, value of HK\$1,000; OR Marshall Acton III Bluetooth Speaker, value of HK\$2,499 (Random Color).

ii. If you successfully open a Designated Account, deposit at least HK\$80,000 into the Designated Account and maintain the same for at least 60 days, maintain daily average assets of HK\$10,000 or above, you can get a Apple Store Gift Card, value of HK\$2,000; OR a HKTVmall electronic Voucher, value of HK\$2,000 ; OR Wellcome Shopping Voucher, value of HK\$2,000; OR Futu Cash Voucher, value of HK\$2,000; OR DJI Neo Fly More Combo, value of

HK\$2,499; OR Dyson Hot + Cool™ AM09, value of HK\$3,380; OR Nintendo Switch OLED, value of HK\$2,680 (Random color).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the Designated Account with the specified amount and is not required to subscribe to or purchase any securities, investment products and/or initiate any transactions or dealings of securities or investment products.

d. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

f. 2. they will only receive an Upgraded Reward and not any Promotion Reward in addition to the Upgrade Reward.

c. MoneyHero reserves the right to amend these Terms and Conditions at any time, including changing the Promotion Period or Promotion Reward or to terminate this Promotion with or without prior notice or liability to users.
