

(2025/05/02 12pm) MoneyHero x 美國運通白金卡

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明, 推廣活動的推廣期為 2025/05/02 12pm 至 2025/05/29 6pm(包括首尾兩日)(「推廣期」)。

3. 推廣活動定義

a. 「指定信用卡」是指 美國運通白金卡。

b. 「信用卡提供者」是指 美國運通。

c. 「新客戶」是指在現時並未持有及於現時所申請美國運通白金卡主卡批核日起計之過去12個月內沒有取消任何美國運通白金卡主卡之申請人。

d. 「合資格消費」是指消費HK\$15,000或以上, 及已清繳年費。

4. 合資格客戶
