MoneyHero x 大新銀行私人貸款條款及細則 - 2025年1月申請獎勵(無須提取貸款) (「推廣活動」)

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 30th September 2024 6pm to - 2025/01/31 6pm, dates inclusive (the "**Promotion Period**").
