# (2025/03/31 6pm) MoneyHero x Dah Sing Card

### 1.合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

### 2.推廣期

除非另有說明, 推廣期為 2025/03/31 6pm 至 2025/04/30 6pm(包括首尾兩天)("推廣期")。
