# MoneyHero x UA亞洲聯合財務(UA) 私人貸款條款及細則 – 202504提取貸款優 惠 (「推廣活動」)

1.客戸於推廣期內經指定MoneyHero網頁成功申請UA亞洲聯合財務(UA)私人貸款(「指定貸款」),並留下有效聯繫資訊,由 UA 客戶服務人員成功聯繫,其貸款申請獲UA確認,及成功遞交MoneyHero獎賞換領表格方可獲享優惠。

- g. 申請人必須留下有效聯繫資訊, 並須由 UA 客戶服務人員成功聯繫, 方可合資格。

#### 5.推廣獎賞及兌換

g. Leave valid contact information and must be contacted by UA Customer Service Officer successfully.

# 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following "**Promotion Rewards**", subject to availability:
