

MoneyHero x WeLab 私人貸款條款及細則 – 2024年10月優惠(須提取貸款) (「推廣活動」)  
(Oct2024) MoneyHero x WeLab - Personal Loan - Drawdown offer

1. 新客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期間

除非另有說明，推廣期間為2024/08/01 12nn至2024/10/31 6pm (「推廣期間」)。

3. 推廣條款

- a. 「指定貸款」指WeLab Bank 私人分期貸款及WeLab Bank私人分期貸款(公務員及專業人士)。
- b. 「產品提供者」指匯立銀行。
- c. 「指定優惠碼」是 NLHERO。

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需：

- a. 為18歲或以上，持有有效香港身份證且在香港有通訊地址的新客戶；
- b. 最低年薪要求：HK\$120,000；
- c. 在被重定向到產品提供者的網站之前向MoneyHero提供有效的電郵地址；
- d. 在推廣期間內使用指定優惠碼通過MoneyHero完整提交指定貸款申請，還款期為24個月或以上；
- e. 在收到MoneyHero獎賞換領表格後7天內完整提交MoneyHero獎賞換領表格；

- b. 合資格客戶將最多可獲得1個推廣獎賞。
- c. 在確認資格後，兌換詳情將通過電子郵件發送至合資格客戶提供給MoneyHero的電郵地址。提供錯誤或不正確信息(由MoneyHero絕對酌情決定)的合資格客戶將無法收到任何推廣獎賞。

Unless otherwise specified, the promotion period of the Promotion is from 2024/08/01 12nn to 2024/10/31 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Loan**” means the **WeLab Bank Personal Instalment Loan and WeLab Bank Personal Instalment Loan (For Civil Servants and Professionals)**.

b. “**Product Provider**” means WeLab Bank.

c. “**Promotion Code**” means “**NLHERO**”

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Minimum annual salary requirement is HK\$120,000;

c. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

d. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated promotion code during the Promotion Period, where the loan tenor is 24 months or above;

e. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

f. Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan ; and

g. Maintain the account for the Designated Loan in a valid state and good condition without any late payments or early repayments.

## 6. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, depending on the loan amount, subject to availability:

i. For loans of between HK\$200,000 and HK\$499,999, you can choose from HK\$2,000 Wellcome voucher or HK\$2,000 Apple Store gift card or HK\$2,000 Trip.com voucher;. ii. For loans between HK\$500,000 and HK\$999,999, you can choose from a HK\$4,000 Wellcome voucher or HK\$4,000 Apple Store gift card orHK\$4,000 Trip.com voucher. iii. For loans betweenHK\$1,000,000 and HK\$1,500,00, you can choose HK\$11,000 Wellcome voucher or HK\$11,000 Apple Store gift card orHK\$11,000 Trip.com voucher.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. If the application for the Designated Loan is not made via the designated promotion code, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward.
