

MoneyHero x LongBridge 條款及細則 限時額外獎勵 - (以下稱「推廣活動」) (202506)

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2025/06/06 12pm 至 2025/06/30 6pm, 包括首尾兩日(以下稱「推廣期」)。

3. 本推廣活動而言：

- a. 「指定帳戶」是指長橋證券戶口。
- b. 「產品供應商」是指長橋證券。
- c. 「新客戶」是指獎勵活動對象為18歲或以上並且在2025/06/30 6pm前未曾開通長橋證券賬戶及存入資金的人士，只限持有香港居民身份證。
- d. 「指定優惠碼」是指「AAKMAY」。

4. 合資格客戶

Terms and Conditions of MoneyHero x LongBridge - Limited Time Extra Incentive - (the “Promotion”) (202506)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/06/06 12pm - 2025/06/30 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Account**” means the LongBridge Account.

b. “**Product Provider**” means LongBridge.

c. “**New Customer**” means customers who are aged 18 or above and have not opened a LongBridge account or made a deposit on or before 2025/06/30 6pm and only for customers who are holding a Hong Kong identity card.

d. “**Designated Promo Code**” means 「AAKMAY」.

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Account through MoneyHero using the designated promo code during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero (and in any event no later than 2025/07/07, including providing their LongBridge Account ID (8 digits) in the “Application Reference Number” section of the MoneyHero Reward Redemption Form;
