

# **(2025/06/26 12pm) MoneyHero x 信銀國際大灣區雙幣信用卡 / 信銀國際Motion信用卡 / 信銀國際香港航空Mastercard®信用卡**

1. 成功通過 MoneyHero 申請指定信用卡並完成以下要求的合資格客戶將獲得推廣獎賞(各自定義如下)。

## **2. 推廣期**

除非另有說明, 推廣活動的推廣期為 2025/06/26 12pm 至 2025/06/30 6pm(包括首尾兩日)(「推廣期」)。

## **3. 推廣活動定義**

a.「指定信用卡」是指 信銀國際大灣區雙幣信用卡 或 信銀國際Motion信用卡 或 信銀國際香港航空Mastercard®信用卡。

b.「信用卡提供者」是指 信銀國際。

c.「新客戶」是指在現時並未持有及於現時所申請信銀國際主卡批核日起計之過去12個月內沒有取消任何主卡之申請人。

d.「合資格消費」是指消費HK\$100。

## **4. 合資格客戶**

為獲得推廣獎賞並成為「合資格客戶」, 客戶需:

a. “**Designated Card**” means the CNCBI GBA Dual Currency Credit Card / CNCBI Motion Credit Card / CNCBI Hong Kong Airlines Mastercard® Card.

b. “**Product Provider**” means China CITIC Bank International.

c. “**New Customer**” means those who have not held China CITIC Bank International Card in the 12 months preceding the date on which their application for a Designated Credit Card is made.

d. “**Eligible Spending**” means HK\$100.

## 4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;

e. Have their application for the Designated Card approved by the Product Provider on or before 2025/07/31, subject to the Product Provider’s system records; and

f. Fulfill eligible spending with 30 days upon card approval.

## 5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following “**Promotion Rewards**”, subject to availability:

- Delsey 30” Top-Lip Opening 4 Wheels Travel Suitcase (value of HK\$4,980; Random color); OR
- Dyson Zone™ Noise Cancelling Headphones (value of HK\$5,980).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who

provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e. If the application for the Designated Card is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward. - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
- (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.

h. By selecting a Cash Reward, Eligible Customers confirm that they are in compliance with all Anti-Money Laundering (AML) laws and regulations.
