

# (2025/02/03 12pm) MoneyHero x Airwallex 企業帳戶

1. 合資格客戶 成功通過MoneyHero申請指定銀行帳戶並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞(定義如下)。

## 2. 推廣期

除非另有說明, 推廣期為2025/02/03 12pm至 2025/02/28 6pm(包括首尾兩天) (“推廣期”)。

## 3. 推廣活動相關定義

- a. “指定銀行帳戶”指 Airwallex企業帳戶。
- b. “銀行帳戶提供者”指Airwallex。
- c. “新客戶”指在申請指定銀行帳戶前 12 個月內未持有Airwallex任何銀行帳戶的客戶。

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”, 客戶需:

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶;
- b. 在被重定向到銀行帳戶提供者網站前向 MoneyHero 提供有效的電子郵件地址;

- a. "Designated Bank Account" means the Airwallex Business Account.
- b. "Product Provider" means Airwallex.
- c. "New Customer" means customers who have not held any bank account with Airwallex in the 12 months preceding the date on which their application for a Designated Bank Account is made as part of this Promotion.

## **4. Eligible Customers**

In order to receive a Promotion Reward and to comprise "Eligible Customers", customers are required to:

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider's website;
- c. Fully complete and submit an application for a Designated Bank Account through MoneyHero using the designated link during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero; and
- e. Have their application for the Designated Bank Account approved by the Product Provider on or before 2025/03/31, subject to the Product Provider's system records.

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
