# 202504 MoneyHero x WeLend - Personal Loan - Drawdown Offer

1.客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶,將獲得推廣獎賞(定義見下文)。

# 2. 推廣期

除非另有說明, 推廣活動的推廣期為 2025/03/31 6pm 至2025/04/30 6pm, 包括首尾兩日(「推廣期」)。

# 3.就此推廣活動而言:

a.「指定貸款」是指 WeLend 特快批核貸款 及【MoneyHero獨家產品】WeLend「銀行用戶尊享貸款」及 WeLend 低息私人貸 款 及 WeLend 結餘轉戶貸款。

# 4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」,客戶需滿足以下條件:

**a. "Designated Loan"** means the WeLend Instant Personal Loan ; and [MoneyHero Exclusive]WeLend "Bank Customer" Lower Interest Rate Loan; and WeLend Personal Loan; and and WeLend Card Debt Consolidation Loan.

b. "Product Provider" means WeLend.

# 4. Eligible Customers

In order to receive a Promotion Reward and to comprise "Eligible Customers", customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider's website;

c. Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period; and

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero.
