### **1. Eligibility**

- Subject to WSOPonline.com’s discretion and the terms and conditions set out below.

- Promotional dates, bonus codes, and minimum deposit will be specified in the marketing collateral.
- Offer is non-transferable and may only be claimed by the invited player.

### **2. Claiming the Bonus**

- Invited players will receive a discretionary casino bonus deposit match offer. Bonus match percentage and maximum deposit amount will be noted in the marketing collateral.
- Players must make a qualifying deposit on the promotional dates between 12:00am and 11:59pm.
- Players must enter the bonus code specified in the marketing collateral to complete their deposit.
- Once the bonus has been claimed and a qualifying deposit has been made, players will be immediately credited with a casino bonus based on the bonus match percentage and maximum deposit amount.
- Players will receive their bonus funds within 72 hours once their deposit is complete.
- Players who redeem the bonus match offer will receive an additional 100 Reward Spins.
- Reward spins are available only on the following games:
  - Bella Italia, Café De Paris, Double Reels, Gods of Gold Daily Jackpot, Golden Twins, Once Upon a Dime Daily Jackpot, Santa’s Double Surprise, Space Arcader, Steampunk Nation Daily Jackpot, and Sunny Reels.
  - Reward spin machine denomination and paylines are set by WSOPonline.com. The denomination will be \$.25, and the paylines will be 25.
- Reward spins will be awarded within 5 days after the offer is claimed and must be used within 7 days.
- Reward spins are only available for use on WSOPonline.com Casino games.
- Players can receive one (1) Bonus Match offer and claim one (1) Rewards Spins bonus during the promotional dates.

### **3. Wagering Requirements**

- Bonus funds are only available for use on WSOPonline.com Casino games found within the WSOPonline.com client.
- Wagering requirements on bonus funds vary based on the game type played. Visit <https://www.wsoponline.com/legal/bonus-policy/nj/> for the contribution rate of each game type.
- Wagering Requirements are defined as 25x on slot games and 50x on all other games.
- Qualifying deposits made to initiate a bonus and all bonus funds are subject to the Wagering Requirements.
- For any wager placed while a bonus is active, funds are first deducted from the player’s cash balance. If no cash is available in the player’s balance, then the player wagers with their bonus funds.

- Once the deposit playthrough has been met or is no longer available, the remaining bonus must be wagered a total of 25x on slot games and 50x for all other games to unlock the winnings.
- As an example, if you receive a \$60 bonus and only play slots, you will have to wager a total of \$1,500 (\$60 x 25) to receive the winnings.
- Players have 7 days to satisfy the Wagering Requirements from the day the bonus funds are awarded. Failing to do so will result in the expiration and forfeiture of any remaining bonus amount.
- Making a withdrawal with any funds locked to a bonus or canceling the bonus itself, prior to satisfying Wagering Requirements, will result in the bonus funds and any bonus winnings being forfeited. However, any unused portion of the original deposit amount will be available.
