Many Core Plus+ incentives are multipliers on Core Plan commissions which means if you build your business in ways that increase your Core Plan earnings, you can increase your Core Plus+ incentives too.





# CUSTOMER SALES INCENTIVE (CSI) upto 5%

CUSTOMER SALES INCENTIVE (CSI) is an Income on Sales to Verified Customers (Pcs). Selling to customers is the foundation of the Amway business.

Eligibility: ABOs at 0% to 3% Sales Commission level in any given calendar month

Reward: Upto 5% Commission Verified Customer Sales\*

### \*CRITERIA TO EARN CSI ON Verified Customer SALES (VCS) TO PCs:

- Orders should be placed by PC.
- Orders should be paid by the PC.
- Orders to be delivered to PC's Registered Address or Pick-Up Order placed by PC.
- · Any Purchase by PC in excess of Recommended Monthly Consumption (system check) will disqualify the order for CSI.
- The order should not have more than 6 eaches per SKU.
- The order should be of less than 200 PV with the exception of 1 Durable item in that order invoice.
- Any returned PC orders on which an ABO has earned CSI, CSI will be reversed on such orders.
- · Discretionary Incentive, subject to good standing with the company. Any manipulative behaviors would fall under the purview of Business Conduct & Rules & appropriate action taken.

# FAQs-CSI

- 1. Will I get CSI on the sales made to non-verified Preferred Customers? No, CSI will only be applicable to the sales made to verified Preferred Customers.
- 2. In case the Preferred Customer returns the products, will it impact my CSI eligibility? Yes, the CSI amount will be reversed in proportion to all the returned products.
- 3. One of my PCs is unable to place order owing to his/her ill-health, I have placed order on his behalf will I get CSI on that order?

While you can place the order for the PC by making yourself as Ordering ABO, the order will not be eligible for CSI.

4. Which Orders placed by PCs would be considered for CSI and which ones would not?

Orders placed by PCs themselves could be of the following types

- a) Online Order for Home Delivery to Registered Address
- b) Online Order for Home Delivery to Ship to Address
- c) Online Order for pick-up from Store (Bopis)
- d) Store Pick Up Order

Of the above types of Single PC Order, type (b) will not be eligible for CSI



### 5. Can ABOs still order for the downline PC, even though they don't receive the CSI?

Yes, this would still be possible, subject to the consent from that PC to place the order, however this would not generate CSI for the sponsoring ABOs. Orders placed without the consent of PC, will not be counted for the sales turnover also appropriate action will be taken.

### 6. Can I check my CSI earnings on orders placed for my personal or Team Pcs?

If the PC order is placed by the servicing ABO or their upline ABO, then such orders will not be eligible for CSI, but eligible for other commission calculations. CSI earning can be checked Real-time on MyBiz portal.

# 7. How would CSI or PV of PC orders be accounted for, on orders placed by uplines (including the Servicing ABO)?

Orders placed for a PC by uplines (including the servicing ABO), on consent by that PC, will continue to be counted towards Group PV for the sponsoring ABO and his uplines as it normally does. No change in counting of PV/BV.

### 8. How is the term "Recommended Monthly Consumption" defined for a specific PC?

All Amway Products have a recommended usage per day per User mentioned. Amway always encourages usage within recommended norms. It has been observed that several high selling SKUs have very high purchase levels by PCs, which is way beyond the recommended usage, even for an extended family.

Amway will calculate the purchase made per SKU per month (rolling 30 days) by all PCs. A safe consumption limit is the recommended usage for a family of 6 members, in a month. Whenever the purchase of any SKU by a PC exceeds the Monthly Consumption limit, the order which exceeds the limit will be disqualified for CSI. CSI will be reversed for such order, if already paid on it.

9. One of my 3 PCs upgraded his/her status from a PC to an ABO towards the middle of the month, would the order place by this PC prior to this change be considered for CSI?
Yes, if the order was placed by the PC within his/her PC status.





# **STRONG START INCENTIVE (SSI)**

Learn rewarding behaviors for achieving Verified customer sale requirements month after month, earn **Up to** ₹25,000/- total in 12 months

This incentive is aimed at encouraging New ABOs get activated through building repeat customer volume by achieving 100 PV from Verified PCs **consecutively** during their first year

# Program Elements:

- New ABOs who Register or PCs migrating to ABOs in July '24 or later
- Must start 100 PV from verified PCs, consistency streak, within 0+2 months of registration
- July'24 & Aug'24 new joinees can start their earning from Sept'24 only
- Earn upon 3, 6, 9 and 12 consecutive months of 100 PV from verified PCs.
- · Once streak is broken, no longer eligible for SSI
- · ABO can earn SSI once in their life cycle
- Only PV from verified PCs would be considered for this incentive

### > How It Works

- During your registration month or the two months following, begin the incentive period by achieving 100 PV from verified PCs in a single month:
- Achieve consecutively, to keep your momentum going and earn all four rewards!
- Payment after 3, 6, 9, 12 months of consistency of 100 PV from verified PCs, monthly

# FAQs-SSI

- 1. Will I get SSI on the sales made to non-verified Preferred Customers?

  No, SSI will only be applicable to the sales made to verified Preferred Customers.
- 2. In case the Preferred Customer returns the products, will it impact my SSI eligibility? Yes, the required 100 PV from verified PCs will be re-checked in proportion to all the returned products. If the value of PC sale falls below 100 PV in a month due to returns, the consistency streak of the ABO will end.
- 3. In Strong Start Incentive (SSI),100 PC PV criteria is on 1 PC? or Multiple PC's? 100 PV from verified PCs can be done from 1 or more Pcs.
- **4. PV** from which Product categories will be considered for SSI? Are there any exclusions? PV from Verified PCs from all product categories will be included for SSI.
- **5.** Can I also earn CSI if I am earning SSI?

  Yes, you can earn CSI also, along with SSI, if the eligibility criteria for CSI is fulfilled.



### 6. Is the same CSI rules on PC orders applicable for SSI?

No, PV from Verified PCs from all product categories & orders will be included for SSI for PY 24-25. CSI rules are separate.

#### 7. When can July'24 new joinees start participating for Strong Start Incentive?

As the program starts from Sept'24, July'24 new joinees can start participating from Sept'24 only. They would have to complete their Entry model criteria and be active ABOs to avail the SSI from Sept'24. Detailed simulations are available in this FAQ.

#### 8. If I joined in Sep'24, when can I start participating for Strong Start Incentive?

You can start the participation in SSI within the same month of joining the Amway Business or within the next 2 calendar months, first payout will be done on completion of the consecutive 100 PV for 3 months from verified PCs.

So, if you joined in Sept'24, you can start your consistency streak from Sept'24, Oct'24 or Nov'24

9. I have qualified and earned SSI for the first quarter but missed the 100 VCS PV 4th month, can I re-start my SSI qualification for 2nd quarter by doing the 100 VCS PV in 5th month.

No, you have to complete consecutive months to stay in the SSI Incentive program.

# 10. Will I get additional incentive If I do more than the required 100 VCS PV in a month or quarter to earn SSI?

No, the Incentive is a fixed amount for all four quarters (3, 6, 9, 12 months) upon completion of SSI criteria in respective quarters.

# 11. I joined in Sep'24 and started participating / earning in SSI, till what pin level I can earn my SSI within the given time frame?

There is no Pin capping for SSI. Once started, you can earn up to Rs. 25000 within 12 months irrespective of commission level achieved.

#### 12. Is SSI also available for a PC migrated to ABO?

Yes, SSI can also be earned by PCs who migrated to ABO. However, SSI can be earned only once (in a period of 12 months) on a single ABO number.

# **BRONZE FOUNDATION INCENTIVE (BFI)**

# > Eligibility for Entry into program:

- ABOs who have been at or below 12% on the Sales Commission Schedule during the Performance Year Sept'2023 – Aug'2024.
- · Have not earned BFI earlier.

# > Eligibility to earn monthly BFI:

- Achieve 9% or higher on the Sales Commission Schedule in a month.
- Have at least three sales teams, each earning a minimum of 3% Sales Commission in the same calendar month.

### > Reward:

- **15**% multiplier on Sales Commission (Personal Sales Commission + Differential Sales Commission) earned in that calendar month.
- Maximum of 12 payments in an 18-month period commencing from the first BFI month.

# FAQs-BFI

1. I missed a few months of BFI qualification after starting my BFI. Can I still earn BFI for 12 months.

All Eligible ABOs can earn BFI for 12 months within an 18-month period. You can get an update on your remaining BFI earning opportunities from MyBiz portal when you log into your account on **www.amway.in** 

2. I have earned 4 BFI months in performance year 2023-24, what multiplier will be applied from September'2024 onwards.

From the performance year Sep'24 to Aug'25, 15% BFI multiplier will be applied on sales commissions of that month.

3. I earned BFI for 3 months in PY-2022-23? If I fulfill the conditions for a new BFI, can I get 12 more months of BFI earnings.

One of the requirements to be eligible for BFI, is that that ABO must not have earned BFI earlier. Since you have had the opportunity to earn 12 BFI earlier, you will not be eligible for BFI anymore.





### **BRONZE FOUNDATION INCENTIVE (BFI) - OTCI**

This incentive is to reward the consistency of Bronze Foundation Incentive earners upon completion of 6 & 12 BFI months. Consistent BFI qualification helps in building a stable foundation towards BBI level.

### Earn BFI One Time Cash Incentive (OTCI)

- Achieve 6 BFI months, Earn OTCI: ₹20,000/-
- Achieve 12 BFI months, Earn OTCI: ₹40,000/-
- Both OTCls are separate, and can be earned separately by an ABO

When ABO completes 12 BFI months, they would earn ₹60,000 (₹20,000 + ₹40,000) besides the 15% multiplier on each BFI month. Both the 6th & 12th BFI month have to be in PY'2024-25 or later.

# FAQs-BFI OTCI

1. I earned BFI for 6 months in PY-2024-25. How much will I get?

On achievement of 6 BFI months, you are eligible for OTCl of ₹20,000/-. This is besides the 15% multiplier on Sales Commission for each eligible month.

2. I completed BFI for 12 months in PY-2024-25. How much OTCI will I receive?

On achievement of 12 BFI months, you are eligible to earn additional OTCI of ₹40,000/-, If you completed both 6th & 12th BFI month in PY'24-25, you can earn total OTCI ₹60,000....₹20,000 once you achieve 6 BFI months + ₹40,000/- once you achieve another 6 BFI months (total 12 BFI months).

3. I earned BFI for 5 months in PY-2023-24 and 7 months in PY-2024-25. Will I receive both the 6 months & 12 months BFI OTCIs?

Yes, on completion of 6 & 12 BFI months in PY'24-25 (even if started in PY 2023-24) you are eligible to earn OTCI of ₹20,000 & ₹40,000

4. I earned BFI for 4 consecutive months but missed the 5th month, can I still participate to earn BFI OTCls for 6 & 12 months?

Yes, you are eligible to earn both OTCls upon completion of 6 months & 12 months BFI qualification within the 18 months of window, if 6th & 12th month done in PY'24-25

5. My BFI Restart window closes in Dec'24. If I achieve my 12th BFI restart month between Sept'24 – Dec'24, will get BFI OTCI?

Yes, you can get BFI OTCl of ₹ 40,000/-, if the 12th BFI month achieved in PY'2024-25.



# **BRONZE FOUNDATION INCENTIVE (BFI) RESTART**

### Entry Criteria:

- ABOs who have earned 12 BFI payments or completed 18 months BFI cycle by Aug'24
- Have been at 12% or below level in PY 2023-24
- · Not earned from BFI Re-start program earlier
- Can re-start from Sept'24 (till Aug'25)

# • Eligibility:

- Achieve 9% or higher on the Sales Commission Schedule in a month.
- Have at least three sales teams, each earning a minimum of 3% Sales Commission in the same calendar month.

#### Reward:

- Upto 12 BFI payments @ 15% Multiplier, in 18 months, from first month of restart
- 6 months OTCI @ Rs. 20,000/-
- 12 months OTCI @ Rs. 40,000/-
- All Calculations for BFI Re-start are same as the regular BFI program (except Entry Criteria)

# FAQs-BFI Restart

1. I was eligible for BFI Re-start in PY 2022-23 but could not qualify a single month. Can I participate in the BFI Re-start from Sept'24

Yes, you can participate & earn BFI Re-start from Sept'24, as you did not earn from the earlier Restart program. However, other criteria for BFI Re-start must be met.

2. I was at SP level in PY 2022-23 and 9% highest in PY 2023-24. Can I participate in the BFI Re-start from Sept'24

Yes, you can participate & earn BFI Re-start from Sept'24, However, other criteria for BFI Re-start must be met.

3. I am eligible for BFI Restart in Sept'24. Can I earn both the multiplier & the OTCls?

Yes, BFI Restart qualifiers will be eligible for all the benefits of a regular BFI earner, which includes both Multiplier & OTCI.

4. Can I track my BFI re-start from Mybiz?

Yes, you can track your BFI Re-start journey from Mybiz. However, the same is expected to be live by Dec'24.

5. I will complete my current BFI period in Dec'24. Can I participate in the BFI-Restart if I start from Aug'25?

No, Eligibility for restart is for ABOs whose regular BFI eligibility has closed by Aug'24. Hence you will not be eligible.



### **BRONZE BUILDER INCENTIVE (BBI)**

### Eligibility for Entry into program:

- ABOs who have been below Silver Producer level in PY'2023-24 and not achieved Gold Producer level since Aug' 2019
- · Have not earned BBI earlier.

### Eligibility to earn monthly BBI:

- Achieve 15% or higher on the Sales Commission Schedule in a month.
- Have at least three sales teams, each earning a minimum of 6% Sales Commission in the same calendar month.

#### · Reward:

- 20% multiplier on Sales Commission (Personal Sales Commission + Differential Sales Commission) earned in that calendar month.
- Maximum of 12 payments in an 18-month period commencing from the first BBI month.

# FAQs-BBI

# 1. I missed a few months of BBI qualification after starting my BBI. Can I still earn BBI for 12 months.

All Eligible ABOs can earn BBI for 12 months within an 18-month period. You can get an update on your remaining BBI earning opportunities from MyBiz portal when you log into your account on **www.amway.in** 

# 2. I have earned 10 BBI months in performance year 2023-24 @30% multiplier, what multiplier will be applied from September'2024 onwards.

From performance year Sep'24 to Aug'25, the 20% BBI multiplier will be applied on sales commissions of BBI months.

#### 3. Can I earn BFI & BBI in the same month?

Yes, you can earn BFI & BBI multiplier in the same month, provided you are within the earning eligibility for BFI program & BBI as per the respective time-periods.

#### 4. What is the criteria to attend the New Bronze Forum?

All First-Time BBI qualifiers would be eligible for an invitation to attend the New Bronze Forum.





### **BRONZE BUILDER INCENTIVE (BBI) - OTCI**

This incentive is to reward the consistency of Bronze Builder Incentive earners upon completion of 6 & 12 BBI months. Consistent BBI qualification helps in building a stable foundation towards Silver Producer level.

- Earn BBI One Time Cash Incentive (OTCI)
  - Achieve 6 BBI months, Earn OTCI: ₹40,000/-
  - Achieve 12 BBI months, Earn OTCI: ₹80,000/-
  - Both OTCls are separate, and can be earned separately by an ABO

When ABO completes 12 BBI months, they would earn Rs. 120,000 (₹40,000 + ₹80,000) from the BBI OTCIs, besides the 20% multiplier on each BBI month. Both the 6th & 12th BBI month have to be in PY'2024-25 or later.

# FAQs-BBI OTCI

- 1. I earned BBI for 6 months in PY-2024-25. How much will I receive?

  On achievement of 6 BBI months, you are eligible for OTCl of ₹40,000/-
- 2. I earned BBI for 6 months in PY-2023-24 and 6 months in PY-2024-25. Will I receive 12 months BBI OTCI?

Yes, on achievement of 12 BBI months (even if started in PY 2023-24) you are eligible to earn OTCI of ₹80,000/-.

3. I earned BBI for 5 months in PY-2023-24 and 7 months in PY-2024-25. Will I receive both the 6 months & 12 months BBI OTCIs?

Yes, on completion of 6 & 12 BBI months (even if started in PY 2023-24) you are eligible to earn OTCI of ₹40,000 &₹80,000

4. I earned BBI for 5 consecutive months but missed the 6th month, can I still participate to earn BBI OTCls for 6 & 12 months?

Yes, you are eligible to earn both OTCls upon completion of 6 months & 12 months BBI qualification within the 18 months of window.

5. My BBI Restart window closes in Dec'24. If I achieve my 12th BBI restart month between Sept'24 – Dec'24, will I get BBI OTCI?

Yes, you can get BBI OTCl of ₹80,000/-, if the 12th BBI month achieved in PY'2024-25.





### **BRONZE BUILDER INCENTIVE (BBI) RESTART**

# Entry Criteria:

- ABOs who have earned 12 BBI payments or completed 18 months BBI cycle by Aug'24
- Have been below Silver Producer level in PY 2023-24
- · Not earned from BBI Re-start program earlier
- Can re-start from Sept'24 (till Aug'25)

### Eligibility:

- Achieve 15% or higher on the Sales Commission Schedule in a month.
- Have at least three sales teams, each earning a minimum of 6% Sales Commission in the same calendar month.

### Reward:

- Upto 12 BBI payments @ 20% Multiplier, in 18 months, from first month of restart
- 6 months OTCI@Rs. 40,000/-
- 12 months OTCI @ Rs. 80,000/-
- All Calculations are same as the regular BBI program (except BBI Re-start Entry Criteria)

# FAQs-BBI Re-start

1. I was eligible for BBI Re-start in PY 2022-23 but could not qualify a single month. Can I participate in the BBI Re-start from Sept'24

Yes, you can participate & earn BBI Re-start from Sept'24, as you did not earn from the earlier Restart program. However, other criteria must be met.

2. I was eligible for BBI Re-start in PY 2022-23 but could qualify for only 2 months. Can I participate in the BBI Re-start from Sept'24

No, the BBI Restart is not open for those who have participated (earned) from the earlier BBI-Restart program.

3. I was at SP level in PY 2022-23 and 15% highest in PY 2023-24. Can I participate in the BBI Re-start from Sept'24

Yes, you can participate & earn BBI Re-start from Sept'24, However, other criteria must be met.

4. I am eligible for BBI Restart in Sept'24. Can I earn both the multiplier & the OTCls?

Yes, BBI Restart qualifiers will be eligible for all the benefits of a regular BBI program, which includes both Multiplier & OTCI.

5. Can I track my BBI re-start from Mybiz?

Yes, you can track your BBI Re-start journey from Mybiz. However, the same is expected to be live by Dec'24.

6. I will complete my current BBI period in Oct'24. Can I participate in the BBI-Restart if I start from Aug'25?

Eligibility for BBI restart is for ABOs whose regular BBI eligibility has closed by Aug'24. Hence you will not be eligible.



#### **CORE PLUS+ LEADER INCENTIVES:**

### PERSONAL GROUP GROWTH INCENTIVE+ (PGGI)

### · Eligibility:

All qualified Silver Producers and above can participate in 'Personal Group Growth Incentive' (PGGI) and earn as per the Chart Below:

### Reward:

10% to 45% Multiplier on maintenance or growth in PQ months Vs previous performance year

- Paid annually, after the end of the performance year.
- Multiplier is identified on the number of incremental PQ months over previous performance year. Multiplier is applied on Sales Commission of all PQ months.

### PQ Month:

Earn a Personal Q (PQ) each month, you reach 10,000 Ruby Volume or 4,000 Ruby Volume with a team at 21% Sales Commission level. Ruby Volume includes non-21% GPV / GBV but excludes PV / BV from a downline Platinum and his/her downline (even if they did not have a 21% month).

# FAQs-PGGI

#### 1. How is the PGGI multiplier applied, will it be paid out monthly or annually?

The PGGI multiplier will be applicable on the personal sales commission and differential sales commission earned by the ABO in PQ months only. PGGI is paid out Annually on total PQ month counts after the closure of the Performance Year as per the table shown above: -

# 2. During the previous Performance Year, I was at 18% commission level. This year I have two PQ months, what would be my Annual multiplier for PGGI calculation?

This is an incremental scenario of 2 PQ months thus, as per the PGGI program an annual multiplier of 25% would be applicable for the PGGI calculation. You can check your PGGI tracking from MyBiz portal on your account on www.amway.in

### 3. Till what pin level am I eligible to earn the PGGI incentive?

All Qualified Silver Producers & higher pin levels are eligible to earn PGGI in each ABO Performance each year as per the published criteria.



### FRONTLINE GROWTH INCENTIVE+ (FGI)

Support downline Team members to achieve a 21% Sales level and Qualified months. Keep increasing the number of teams with sales qualifying them at the 21% Sales Commission level and get rewarded every year.

# • Eligibility:

- All qualified Founders Platinum and above can participate in 'Frontline Growth Incentive'.
- Must be a Qualified Founders Platinum in the Performance Year to participate in FGI Incentive.

### Reward:

10% to 45% Multiplier on maintenance or growth in FQ months Vs previous performance year

- · Paid annually, after the end of the performance year
- Multiplier is identified on the number of incremental FQ months over previous performance year. Multiplier is applied on total Leadership + Group Development Commission of all FQ months.

### FQ Months:

- Earn a Frontline Q (FQ) each month for every in-market frontline Sales team that qualifies at 21% Sales Commission level.
- Maintain or increase FQs compared to the previous Performance Year.
- Multiplier is identified on the number of incremental FQ months over previous performance year.

# FAQs-FGI

### 1. How is the FGI multiplier applied, will it be paid out monthly or annually?

The FGI multiplier will be applicable on the Leadership Commission and Group Development Commission earned by the ABO on the number of incremental FQ months over previous performance year. FGI is paid out Annually after the closure of the Performance Year.



### 2. What is the minimum qualification level to participate in the FGI incentive?

One must be a qualified Founders Platinum to participate in the FGI incentive program.

# 3. Can I qualify for the FGI incentive on qualified in-market & non-in-market frontline Sales teams?

One must earn the FQ months from the in-market sales team & Volume only, to be eligible for the FGI incentive.

4. I have attained New Sapphire level with an increase in my FQ Count. But I have not completed Founders Platinum Qualification this year. Can I earn FGI?

It is mandatory to Qualify as a Founders Platinum level to be eligible to earn FGI Incentive. In this case, you will not be eligible for FGI.

### 5. Will the same Multiplier table continue beyond 2025-26 also?

Currently the multipliers announced are extended for PY 2024-25 only. Multipliers for subsequent years will be announced closer to the start of each Performance Year.





### TWO-TIME CASH INCENTIVE+ (TTCI)

ABOs can qualify for a Cash Incentive the first time they reach a new pin Level and earn another incentive of same value by requalifying the same pin next year.

### Eligibility:

- New & First Year Re-qualifiers for Platinum, Founders Platinum, Emerald, Founders Emerald, Diamond & Founders Diamond pin.
- Requalification payment earned if ABO achieves same Pin level in the subsequent performance year.
- For Platinum & Founders Platinum, only FIRST TIME QUALIFIERS will be eligible for the TTCI & First Year Requalification Incentive.
- For In-market Emeralds & above, the qualification history will be checked from PY'15 (Sep'14).
- Payments are cumulative: an ABO can earn multiple Two-Time Cash Incentive payments for multiple qualifications during a year.

# FAQs-TTCI

- 1. I qualified as a Founders Platinum pin level in the previous performance year. This year (PY 2024-25), I would qualify as a New Sapphire and Founders Sapphire pin levels, will I get the TTCI incentive for New Sapphire and Founders Sapphire both?
  - Sapphire and Founders Sapphire both Pin levels are not included in the TTCl schedule, hence you will not be eligible for TTCl on the same.
- 2. I was at the Gold Producer pin level in the previous PY 2023-24, in the PY 2024-25, I aspire to qualify as a New Platinum Pin level and Founders Platinum Pin level, what incentives will I get under the TTCl incentive program?

You will be eligible for TTCl for both the Qualification levels once the qualifications are approved for release.



3. I have qualified New Platinum in PY'24 and earned TTCl as well, what amount will I get if I complete my FYRQ qualification in Py'25?

You will be eligible to get the amount which is published (refer above table) for performance year Sep'24-Aug'25.

4. My current pin is Sapphire, I qualified as Emerald Pin level in PY'2012 & PY'2021. If I requalify as an Emerald Pin level in PY'2025, will I receive the Core Plus TTC!?

You will not be eligible for Core Plus TTCl, as you have an Emerald Pin level after PY 2013-14. However, you can participate in the "A70 Consistency Program" Incentive for Comeback Emerald & above levels.

5. I will qualify as a New Diamond Pin level in PY'2024-25 and 5 of my Q-6 teams would be inmarket Sales teams. Can I receive the TTCI?

Core Plus Incentives are based on in-market Volume & Qualifications only. Hence, while you may complete the Diamond Pin level qualification, you will not be eligible for the Diamond Pin level TTCI.

- All Core Plus Incentives are discretionary incentives dependent on the ABO building the business in the spirit of the Rules of Conduct and being in Good Standing with the Company.
- The Incentives mentioned in the program are applicable for Sept'24 to Aug'25

  delayed due to programming getting live. Payments for such components will be made after
  system programming is ready.
