1. Topic: Mr. Broaden called the meeting to order at 10:00 AM

2. Topic: Commissioner's Remarks

The Commissioner congratulated everyone on a great 2019 season. He mentioned his appreciation for all of the effort that the coaches have been putting towards enhancing their programs and providing each individual student-athlete with a first-class

experience.

3. Topic: Previous Minutes

Issue: Review of the Volleyball Coaches' and Committee Meeting minutes from January 16,

2019. No changes were recommended to the previous minutes.

4. Topic: Coordinator of Volleyball Officials Report.

Mr. Leake highlighted a few topics on the officials report he sent to all of the coaches prior to the teleconference. He discussed the process of assigning officials and informed the coaches that officials will wear headsets starting in the 2020 season. Lastly, if you

5. Topic: NCAA Legislation and Compliance Updates.

King reviewed a select group of the proposals in the current legislative cycle; all but one of which will be voted on during the April meeting of the Division I Council. The coaches were encouraged to contact their Athletics Director and compliance staff prior to the April vote to indicate their support of or opposition to any of the proposals.

6. Topic: Future Schedules

Issue: Mr. Yaman reviewed the 2020, 2021, and 2022 "Matrix" Conference schedules and the

2020 "Ghost" Conference Schedule. After seeing the matrix format through fully, the coaches recommended that Wofford, Furman and The Citadel should remain in the pod due to their central location. Mr. Yaman will produce a 2021 future schedule following

this recommendation for review by the coaches.

7. Topic: 2020 Volleyball Championship

Mr. Broaden reminded the coaches that the Championship will be November 20-22, 2020 and hosted by Samford. The First Round Match can take place November 16 or

17 and will be hosted by No. 8 Seed.

8. Topic: Sport Regulations

Issue: Mr. Broaden informed the coaches of the yearly administrative changes to the

officiating fees, championship information and the language of the updated

ejection/suspension policy.

9. Topic: Other Business

Issue: a. Championship Banquet - Mr. Chan proposed having a banquet to present regular

season awards at the championship the day prior to the start of the quarterfinals. He believes this will better acknowledge the award winners for their accomplishments during the season. The Conference will continue to refine the regular season award acknowledgment process at the championships. However, due to the timing of the balloting and announcement of the award winners, it would be too short of a lead time to have the awards engraved and ready for presentation on the quarterfinal day of the

championship.
