Parent/Legal Guardian Consent and Agreement

I am the parent or legal guardian of the minor participant identified above (the "Minor"). I request and consent to the Minor's attendance at, entry into, and participation in the H-TOWN CLASSIC 3-on-3 basketball tournament, including any related warm-ups, practices, contests, demonstrations, clinics, activations, appearances, photo or video sessions, and other activities occurring in connection with the event (collectively, the "Event"). In consideration for the Minor being permitted to attend, enter, participate in, or remain at the Event, I agree as follows on my own behalf and, to the maximum extent permitted by law, on behalf of the Minor.

IMPORTANT NOTICE: THIS DOCUMENT AFFECTS LEGAL RIGHTS. BY SIGNING BELOW, I AM CONSENTING TO THE MINOR'S PARTICIPATION, ASSUMING RISKS, AGREEING TO INDEMNIFY THE RELEASED PARTIES, AND RELEASING CLAIMS, INCLUDING CLAIMS THAT MAY ARISE FROM THE ORDINARY NEGLIGENCE OF THE RELEASED PARTIES, TO THE MAXIMUM EXTENT PERMITTED BY LAW.

1. Assumption of Risk; Health, Fitness, and Supervision

I understand that basketball and related Event activities involve inherent and other risks, including but not limited to: strenuous physical activity; falls; slips or trips; uneven, wet, crowded, or hazardous playing surfaces; contact or collisions with other participants, spectators, objects, signage, structures, or equipment; weather or heat-related conditions; dehydration; fatigue; illness or exposure to communicable disease; equipment failure; negligent first aid, emergency response, or rescue operations; and other risks that may result in bodily injury, illness, disability, death, emotional distress, or property loss or damage.

I am responsible for determining whether the Minor is physically and medically able to participate. I represent that the Minor has no condition, impairment, disease, infirmity, medication, or treatment that would prevent the Minor's safe participation, or I have elected to allow the Minor to participate notwithstanding any such condition and accept all related risk. I agree that the Minor should stop participating and seek assistance if the Minor experiences pain, dizziness, shortness of breath, illness, or any other concern.

I AM RESPONSIBLE FOR THE MINOR'S PARTICIPATION, CONDUCT, AND COMPLIANCE WITH EVENT RULES. I AGREE TO SUPERVISE THE MINOR OR ENSURE APPROPRIATE SUPERVISION, AND I KNOWINGLY AND VOLUNTARILY ACCEPT AND ASSUME ALL RISKS, KNOWN AND UNKNOWN, FORESEEN AND UNFORESEEN, ARISING OUT OF OR RELATING TO THE MINOR'S ATTENDANCE AT, ENTRY INTO, PARTICIPATION IN, OR PRESENCE AT THE EVENT, WHETHER CAUSED BY THE ORDINARY NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE, TO THE MAXIMUM EXTENT PERMITTED BY LAW.

2. Release, Waiver, Covenant Not to Sue, and Parent/Guardian Indemnity

For purposes of this Waiver, "Released Parties" means Academy Ltd. d/b/a Academy Sports + Outdoors; Nike, Inc.; Jordan Brand; the H-TOWN CLASSIC organizers, operators, sponsors, promoters, partners, advertisers, host site owners or operators, vendors, contractors, and volunteers; and each of their respective parent, subsidiary, and affiliated entities, and each of their respective owners, directors, officers, managers, members, employees, agents, representatives, successors, and assigns.

TO THE MAXIMUM EXTENT PERMITTED BY LAW, I, FOR MYSELF AND FOR MY SPOUSE, HEIRS, BENEFICIARIES, PERSONAL REPRESENTATIVES, EXECUTORS, ADMINISTRATORS, ASSIGNS, AND OTHER SUCCESSORS OF ANY KIND, AND ON BEHALF OF THE MINOR TO THE MAXIMUM EXTENT PERMITTED BY LAW, HEREBY RELEASE, WAIVE,



DISCHARGE, AND COVENANT NOT TO SUE THE RELEASED PARTIES FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, ACTIONS, CAUSES OF ACTION, LOSSES, LIABILITIES, DAMAGES, COSTS, AND EXPENSES OF ANY KIND, INCLUDING PERSONAL INJURY, ILLNESS, DISABILITY, DEATH, PROPERTY DAMAGE, PROPERTY LOSS, RIGHT OF PUBLICITY, PRIVACY, DEFAMATION, FALSE ENDORSEMENT, COPYRIGHT, TRADEMARK, OR OTHER CLAIMS ARISING OUT OF OR RELATING TO THE MINOR'S ATTENDANCE AT, ENTRY INTO, PARTICIPATION IN, OR PRESENCE AT THE EVENT, INCLUDING CLAIMS ARISING OUT OF OR CAUSED BY THE ORDINARY NEGLIGENCE, ACTS, OR OMISSIONS OF ANY RELEASED PARTY, EXCEPT TO THE EXTENT SUCH CLAIMS CANNOT BE RELEASED UNDER APPLICABLE LAW.

I agree to indemnify, defend, and hold harmless the Released Parties from and against any claims, losses, liabilities, damages, costs, or expenses, including reasonable attorneys' fees, arising out of or relating to: (a) the Minor's attendance, entry, participation, presence, or conduct at the Event; (b) my breach or the Minor's breach of this Waiver or Event rules; (c) any claim brought by me, by the Minor, or by or on behalf of either of us contrary to this Waiver; and (d) any allegation that my consent, authority, or signature was ineffective, incomplete, or unauthorized, in each case to the maximum extent permitted by law.

3. Content Capture; Minor Publicity and Media Release

I understand that photographs, video, audio, livestreams, interviews, statements, social media content, recordings, creative expression, name, image, likeness, voice, persona, biographical information, team name, jersey or apparel, and other depictions of the Minor may be captured, created, recorded, broadcast, streamed, photographed, posted, published, edited, cropped, modified, combined with other content, or otherwise used in connection with the Event (collectively, "Depictions").

I hereby irrevocably consent to the capture and recording of the Minor's Depictions and grant Academy Ltd. d/b/a Academy Sports + Outdoors, Nike, Inc., Jordan Brand, the Event sponsors, and each of their respective affiliates, agencies, licensees, sublicensees, successors, and assigns the unrestricted, worldwide, perpetual, royalty-free right and permission to use, reproduce, display, distribute, publish, post, broadcast, stream, transmit, edit, adapt, crop, modify, create derivative works from, license, sublicense, and otherwise exploit the Minor's Depictions, in whole or in part, in any media now known or later developed, including websites, social media, digital advertising, broadcast, print, in-store, out-of-home, internal communications, public relations, and promotional or commercial materials, without further notice, inspection, approval, or compensation.

I waive and release, on my own behalf and on behalf of the Minor to the maximum extent permitted by law, any and all claims arising out of or relating to the capture, recording, editing, use, or exploitation of the Minor's Depictions, including claims for right of publicity, right of privacy, misappropriation, false endorsement, copyright, moral rights, trademark, defamation, disparagement, or any alteration, distortion, blurring, optical illusion, composite use, or use in any context, except to the extent such claims cannot be waived under applicable law.

4. Event Conduct; Compliance

I agree that the Minor will comply with all Event rules, instructions, safety requirements, directions from Event personnel, and facility requirements. I understand that the Released Parties may refuse entry, remove, disqualify, or suspend the Minor's participation for unsafe conduct, unsportsmanlike conduct, violation of rules, or conduct that may harm the Event or others. I am responsible for the Minor's conduct and for any guests or spectators associated with the Minor.

5. Medical Treatment

If the Minor is injured or becomes ill at the Event, I authorize first aid, emergency medical care, transport, or other treatment deemed appropriate by Event personnel or medical responders. I understand the Released Parties do not undertake to provide medical care and are not responsible for medical expenses or outcomes, except to the extent required by applicable law.

6. Governing Law; Severability

This Waiver is intended to be as broad and inclusive as permitted by the laws of the State of Texas and shall be governed by Texas law, without regard to conflict-of-law principles. If any provision is held invalid or unenforceable, the remaining provisions shall remain in full force and effect and the invalid or unenforceable provision shall be enforced to the maximum extent permitted by law.
