## Finding Notes

The USA Swimming National Board of Review appoints panels to review various appeals or grievances throughout the organization. Most of the cases before the panel are background check appeals, with weekly meetings to deal with these appeals being common.

USA Swimming is granted an exception to allow for the National Board of Review to be an "Other" Committee in hearings not involving Designated Committee topics. Any time the content of an item before the panel touches on governance, finance or elite athletes, the panel must be comprised with athletes as per designated committee rules. If not, the NGB may comprise a panel in keeping with "Other" committee composition rules. Both rules are outlined in Section 8 of the USOPC Bylaws.

## Finding Notes

USA Swimming has historically had an athlete body that is comprised of a broad group of athletes, including age-group athletes. While the NGB has stood up an AAC that complies with USOPC requirements, they wish to retain this avenue for athlete voice from among this group of athletes. **As an "Other" Committee**, the Actively Engaged athletes will not be restricted in terms of committee composition while the AAC skews to 10 Year and 10+ athletes in the sport.
