The international events noted above are Team USA Events with NGB Led selection processes.

The USA Boxing National Championships require qualification via the USA Boxing National Championship Qualifiers, ensuring an elite field of competitors.

The USA Boxing Qualifiers are a top-level competition and finishing in the top half indicates an elite level of accomplishment in the sport.

Finally, the USA Boxing Team Selection event is a key event in the selection process for international competitions.

Golden Glove events are sanctioned by USA Boxing and are an important event on the pathway to elite competitions. The same applies to Local Boxing Club and Regional events. With the large amount of LBCs in USA Boxing, all requiring athlete representation, this also can help ensure that the athlete voice at the LBC level will often be athletes engaged at that same level.
