In the course of the meeting with the Panel, it became apparent that the NGB intended for this level of athlete to be included in their submission but had not included them in the original submission with the idea that this would be redundant. Upon more consultation with the NGB and, specifically, with the NGB's USOPC AAC representative, it was clear that the addition of this event was important and would also capture elite athletes as the IBU World Cup is an elite international competition and selection to Team USA is overseen by an NGB selection process.

The Working Group appreciated the NGB's request to add this level of competition to ensure it would have a sufficient pool of athletes to fill the governance roles required. While the IBU Cup is defined as a development circuit leading to the IBU World Cup, the athletes are competing at a high level and selection to the team is overseen by the NGB via a selection process.

The shortage of athletes for this NGB was clearly a result of a low number of athletes qualifying for 10 Year status via delegation events. With a relatively small team at the Winter Olympic Games and no competition at the Pan American Games, the NGB generates only a small number of athletes every quad through the primary means of delegation events.
