All of these categories and competitions are comprised of elite athletes, working at the highest levels of the sport. The athletes selected to the IF World Championships are selected via an NGB led selection process.

The Veterans and Kata categories are not contested at the Olympic, Paralympic, Pan Am or Para Pan Am Games and thus have historically been limited in terms of Board representation. Both the NGB and the AAC agreed that these athletes are elite in their sport and their perspective will substantially be that of an elite athlete should they be elected or appointed to a governance role.
