¹ With respect to the lawsuits related to Dr. Larry Nassar and USA Gymnastics contained in the 2020 Impact Report Summary, a global settlement was reached in the USA Gymnastics bankruptcy proceeding to resolve all abuse claims in December 2021 pursuant to a joint plan of reorganization ("Joint Plan"). The Joint Plan became effective on April 25, 2022, at which time the global settlement was funded. Settlement distributions are set to be underway, and plaintiffs must dismiss their lawsuits with prejudice within ten days after receiving their settlement distributions.
