



CERTIFICATION FOLLOW-UP OF USA SHOOTING

Executive Summary

In December 2024, the United States Olympic and Paralympic Committee (USOPC) Board of Directors renewed the certification of USA Shooting as a National Governing Body (NGB) with a status of Renewal with Conditions. In accordance with the CRG's recommendation ratified by the USOPC Board of Directors, USA Shooting had until September 30, 2025 to fulfill the conditions of certification outlined in the conditional certification report. After this deadline, the CRG evaluated the NGB's progress and now provides this updated recommendation to the USOPC Board of Directors.

As a result of USA Shooting's action to meet the conditions outlined in the December 2024 conditional certification, the CRG recommends that USA Shooting's certification status be upgraded to Renewal in Good Standing for its certification term. The details of the CRG's supplemental review are included in the following report.

NGB Certification Overview

NGB Certification History

The CRG began a certification renewal review of USA Shooting in late 2023, based on the USOPC's quadrennial certification renewal schedule. The CRG paused its renewal review as a result of broader organizational work being conducted with USA Shooting to ensure the sustainability of the NGB, before resuming the review in Q3 2024. As a result of its review, the CRG recommended that USA Shooting be certified with a status of Renewal with Conditions. The USOPC Board of Directors accepted this recommendation on December 12, 2024. The ratification of the Renewal with Conditions status began a remediation period for USA Shooting to resolve the conditions the CRG put in place for its certification

renewal. USA Shooting's remediation period ran through September 30, 2025.

Certification Conditions

NGB Actions Taken

Remediation Actions

USA Shooting executed all remediation work to fulfill the conditions of its certification. The USOPC's Audit department reviewed and tested USA Shooting's remedial actions and validated execution in line with the NGB Compliance Standards to resolve the related audit findings. While some audit findings remain open, the Audit department has determined that they are not high-risk and that the organization has made sufficient progress to satisfy all conditions of certification.

Conclusion

Based on the remediation actions detailed above, the CRG concludes that USA Shooting has resolved the conditions of its previous Renewal with Conditions certification. USA Shooting completed outlined requirements and there are no additional outstanding areas of concern affecting its certification status at this time. Accordingly, the CRG recommends that USA Shooting's certification status be upgraded from Renewal with Conditions to Renewal in Good Standing for its current certification term.
