The NGB did not present this competition in the initial submission, but it became clear in the course of the review that the World Championship had been used to generate athlete eligibility historically and should continue to be used as such. The World Championship is the top elite event for the sport internationally and Team USA athletes are selected via an NGB led selection process.

The event is operated by the Continental Federation as a Team USA event with Team USA competitors chosen via an NGB led selection process. This competition is long-established in the sport and eligibility can be generated for participation going back to 1977.

The USBC Team Trials are a competition format that serves as the selection event for major international competitions and is the direct qualifier for the IF's World Cup competition. Invitations to the camp are based on an NGB led selection process. Participants that finish in the top 3 of this selection event are eligible to serve as athlete representatives, as per the NGB request.

As this competition format has been in place for some time, the NGB requested and the panel agreed that eligibility via this competition can apply to athletes who participated as early as 1977. The panel clarified that the 1977 date would apply to both men and women.
