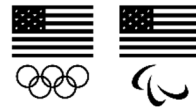

To help the panel reach their decision, please answer the following questions:

1. How many individuals are in your current eligible athlete representative pool?
 - 0- To date USAFB has not participated in a "delegation event" pursuant to IFAF policy.
2. How many athletes will the requests add to the eligible athlete representative pool?
 - 257 Eligible Athletes
 - 91 Athletes from Flag Football
 - 165 Athletes from Tackle Football
3. At what date will the competitions be added to the eligible competitions (i.e., beginning in 1995). (When choosing this year, please consider when competitions became gender equitable to avoid bringing forward past inequities as much as possible.)
 - Proposed Eligible Competitions
 - Flag:
 - IFAF Flag Football World Championship – 2014, 2016, 2018, 2021, 2024
 - The World Games – 2022
 - IFAF Americas Continental Championship – 2023
 - Tackle:
 - IFAF Men's Tackle World Championship – 2015
 - IFAF Women's Tackle World Championship – 2017, 2022
 - IFAF U20 Tackle World Championship – 2018 (*Missing Roster Information*), 2024
4. Are any of the requested competitions age-restricted (e.g., U23, Junior, Masters or Veterans)?
 - No.
5. Are there any other things the panel should know?
 - Flag football was added to the Los Angeles 2028 program in October 2023. Therefore, there are no traditional delegation events to pull eligible athletes from. The above numbers are representative of the following definitions.

- USA Football will launch its Athlete Advisory Council in February 2025. Therefore, these definitions were reviewed and approved by athlete representatives on the USA Football Board of Directors in September 2024.
- Definitions:
 - 10-Year Athlete – *An athlete who participated as an adult (over 18) as a member of the U.S. National team active roster in IFAF-sanctioned international competition.*
 - 10+-Year Athlete – *An athlete who has participated as an adult (18 and older) as a member of the U.S. National Team active roster in IFAF-sanctioned flag football international competition but not within the previous 10 years.*

All submissions must be approved by the internal NGB Athlete Advisory Council (NGB AAC). Signature of the NGB AAC Chair to attest to this is required prior to submission.

Panel Approval

Section 8.5.1 of the USOPC Bylaws grants the NGB Athlete Representative Review Working Group the authority to review and approve any deviations from the requirements of Section 8.5 regarding Athlete Representation on NGB Boards, Designated Committees, and application of the NGB 10 Year and 10 Year+ Athlete Definitions. Approvals are granted by a majority vote out of three panel members. Unless otherwise noted, exceptions are valid through the end of the current quadrennium.
