They further outlined that for most of the functions of these committees, any action taken would have to be ratified by the Board and/or USA Hockey Congress before going into effect.

The NGB and AAC agreed that these committees deal with areas that are not of specific interest or engagement from the elite athlete community and that the elite athlete group is not interested in serving in these roles.

The NGB further outlined that these committees have no decision making authority on their own as their work product needs to be ratified by the Board or USA Hockey Congress before taking effect.

The NGB noted, and the AAC concurred, that team selection in the sport is often led by professional sport General Managers and it was important to maintain that connection to professional leagues in the selection process. They also agreed that athlete voice was elemental to the team selection process. The NGB outlined that there is a strong pool of 10+ Year athletes serving in those professional team/league roles now, but only a small handful of 10-year athletes doing so.

The panel agreed that the NGB may have either 10 Year or 10 Year+ athletes serving on these committees without restriction of how many of each type of athlete. The requirement for half of the athletes on a para-sport selection committee coming from para competition remains intact.

USA Hockey's Congress will be comprised of a large body of voters encompassing many stakeholder groups. The role of the Congress will be related to governance especially and thus the Congress will be a Designated Committee.

The NGB and AAC agreed that the best mode of weighted voting for the athletes at the Congress was to give each athlete two votes, as opposed to a single vote for other

delegates. The two votes per athlete will aggregate to be 1/3 of the votes in the Congress. The panel approved this method of weighting.

The NGB and AAC agreed that these events are elite international competitions for which Team USA is selected via an NGB led selection process. The age restricted categories requested are elite events in the context of the sport.

For the purpose of conferring 10+ Year status on athletes, the events have been made eligible starting in the year in which there was gender equity in the events offered by the IF.

The IF does not offer a U20 Women's World Championship and thus it was not included in the request. The NGB was encouraged to seek approval for such an event should the IF ever start organizing one.
