EXECUTIVE SUMMARY

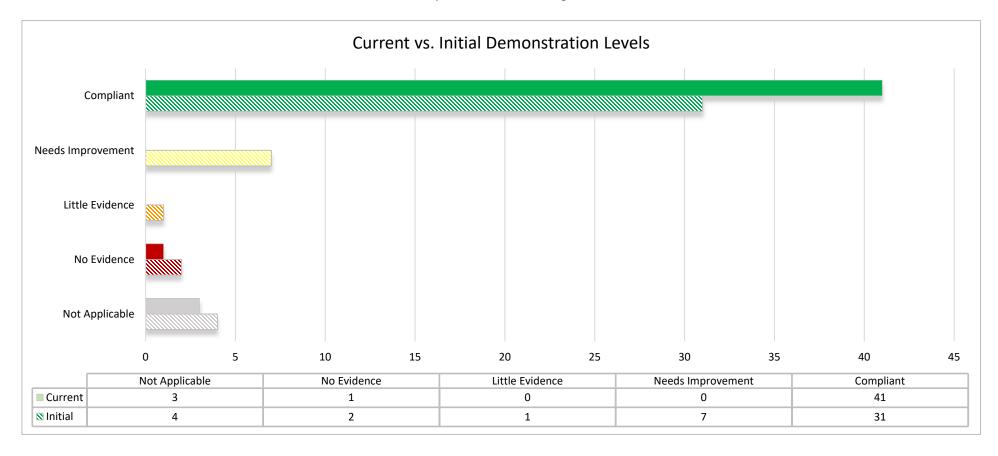
Background, Scope, and Objectives

The United States Olympic & Paralympic Committee's (USOPC) NGB Audit department (Audit) completed an audit of USA Gymnastics on November 10, 2021. The purpose of the audit was to determine if USA Gymnastics complies with the requirements of the NGB Compliance Standards (Standards) and to conduct testing in areas that present an increased risk to athletes, other members, and/or USA Gymnastics. The audit focused on the policies and procedures in the areas of Governance and Compliance, Financial Standards and Reporting Practices, Athlete Protections and Rights, Sport Performance, and Operational Performance.

Following the audit, NGBs have 120 days, unless otherwise specified, to provide evidence of remediation to Audit. Based on the evidence provided, Audit has assigned a Follow-up Demonstration Level¹ of Compliant, Needs Improvement, Little Evidence of Compliance, or No Evidence of Compliance. Details are provided in the findings below.

Follow-up Summary

Based on the evidence of remediation provided, USA Gymnastics has remediated nine findings. One finding remains open. As of July 8, 2022 USA Gymnastics is 91% compliant. Additional details are outlined below.

Subsequent Updates

In the report issued in November 2021, two Standards were pending a determination Status updates are as follows:

Financial Stability – B.1 a

USA Gymnastics' Audited Financial Statements for the years 2018 - 2020 are in progress following resolution of their Chapter 11 bankruptcy case in 2022. Until the audited financials are completed and made available to the USOPC, Audit will be unable to accurately assess the financial stability of the organization. Additional updates on this standard will be provided in the Certification Report.

Child Protection and US Center for SafeSport – C.1 a and C.2

The U.S. Center for SafeSport (the Center) issued an audit report for USA Gymnastics on October 28, 2021, which contained findings. USA Gymnastics received a closure letter from the U.S. Center for SafeSport stating corrective action was taken and is compliant with this standard.

NGB AUDIT FINDINGS - FOLLOW-UP STATUS

All Standards are evaluated against the 2020 Implementation Guide for Audit Standards. Bylaws references are based on the USOPC Bylaws approved in June 2020.

	FINDING: There are elements missing from USA Gymnastics' Whistleblower and Anti-Retaliation Policy related to reporting and enforcement.	USA Gymnastics updated its Speak Up and Anti-Retaliation policies to reflect the process already set forth in its Grievance Procedures, which requires reports be provided to the Ethics & Grievance Committee and that the resolution be executed by disinterested parties. A copy of the updated policy has been provided to NGB Audit.

FINDING: Out of the 15 grievance complaints reviewed, there were seven complaints that were not resolved timely, five instances where the complainant was not provided notice of the resolution, and four instances where no closure date was documented. However, the issues were all from complaints filed in 2020. USA Gymnastics has made significant improvements to its grievance resolution process in 2021, as evidenced by the two grievances sampled in this period.

As USOPC Auditors note, USA Gymnastics made improvements to their grievance process as reflected in the 2021 cases and will continue to follow the updated procedures.

Follow-up Level: Compliant

Audit reviewed two grievances and concluded that the grievances were resolved in a timely manner and notice of the resolution was provided. USA Gymnastics is now compliant.

Additional updates on findings that have not been remediated will be provided in the NGB Certification Report.
