# **Consultation Results: Morningstar Thematic Indexes**

Morningstar Indexes has decided to move forward with the methodology enhancements to the following indexes proposed in a pair of consultations (<u>US Thematic Indexes</u>, <u>Morningstar DM Big Data & Robotics 50</u>) for the following indexes:

- Morningstar US Big Data & Analytics
- Morningstar US Digital Infrastructure & Connectivity
- Morningstar US Exponential Technologies Healthcare
- Morningstar Developed Markets Big Data & Robotics

# **Morningstar US Big Data & Analytics**

This index will be refocused on the Artificial Intelligence theme and will drop Bioinformatics as a sub-theme. Along with this change, the index will be renamed Morningstar US Artificial Intelligence. This update is intended to provide more targeted exposure, as Bioinformatics tends to be closely tied to the healthcare sector. This also aligns with the evolution of the Big Data & Analytics theme in the Morningstar Exponential Technologies Index.

Morningstar US Digital Infrastructure & Connectivity

This index will move to a more granular 0-4 thematic scoring scale from its current 0-3 scale, as shown below.

This is intended to align to the standard equity research thematic scoring framework and enhance the index's thematic purity by providing more separation across eligible stocks.

# **Morningstar US Exponential Technologies Healthcare**

This index will be refocused around the Healthcare Innovation theme and will no longer target the Bioinformatics theme separately from Healthcare Innovation, as Bioinformatics is slated to become a sub-theme under Healthcare Innovation. As such, stocks with exposure to Bioinformatics will still be eligible for inclusion. With this change, the index will be renamed Morningstar US Healthcare Innovation.

# **Morningstar Developed Markets Big Data & Robotics 50**

This index will be refocused on the Artificial Intelligence (AI) and Robotics themes, where AI will replace Big Data & Analytics, which will drop Bioinformatics as a sub-theme. Along with this change, the index will be renamed Morningstar Developed Markets Artificial Intelligence & Robotics 50. This update is intended to provide more targeted exposure and align with the evolution of the Big Data & Analytics theme in the Morningstar Exponential Technologies Index.
