

**HOLIDAY INN CLUB VACATIONS NEW ORLEANS RESORT GRAND OPENING SWEEPSTAKES**  
**OFFICIAL RULES**

<b><u>Third Entry Period:</u></b> Begins February 11, 2021 at 12:00:00 AM ET– Ends February 18, 2021 at 11:59:59 AM ET	<b><u>Eighth Entry Period:</u></b> Begins February 16, 2021 at 12:00:00 AM ET– Ends February 18, 2021 at 11:59:59 AM ET
<b><u>Fourth Entry Period:</u></b> Begins February 12, 2021 at 12:00:00 AM ET– Ends February 18, 2021 at 11:59:59 AM ET	
<b><u>Fifth Entry Period:</u></b> Begins February 13, 2021 at 12:00:00 AM ET– Ends February 18, 2021 at 11:59:59 AM ET

Fourth Entry Period – At 12:00:00 PM ET on February 12, 2021, Sponsor will upload a post to Social Media Platforms asking followers to comment with their favorite thing to do with family on vacation. An eligible entrant may enter the Sweepstakes by commenting on the post with their favorite thing to do with family on vacation.
- v. Fifth Entry Period – At 12:00:00 PM ET on February 13, 2021, Sponsor will upload a post to Social Media Platforms asking followers to comment with whom they like to travel. An eligible entrant may enter the Sweepstakes by commenting on the post with whom they like to travel.
- vi. Sixth Entry Period - At 12:00:00 PM ET on February 14, 2021, Sponsor will upload a post to Social Media Platforms asking followers to comment on the first thing they would do with their family in New Orleans. An eligible entrant may enter the Sweepstakes by commenting on the post with the first thing they would do with their family in New Orleans.
- vii. Seventh Entry Period - At 12:00:00 PM ET on February 15, 2021, Sponsor will upload a post to Social Media Platforms asking followers to comment with what they found the most interesting about our New Orleans Resort lobby mural. An eligible entrant may enter the Sweepstakes by commenting on the post with what they found most interesting about our New Orleans Resort lobby mural.
- viii. Eighth Entry Period - At 12:00:00 PM ET on February 16, 2021, Sponsor will upload a post to Social Media Platforms asking followers to comment with why they want to go to New Orleans. An eligible entrant may enter the Sweepstakes by commenting on the post with why they want to go to New Orleans.

A person may enter the Sweepstakes a total of eight (8) times. You must be a registered Instagram or Facebook user to participate. Instagram and Facebook account registration is free and can be obtained by logging onto <http://instagram.com> or <http://facebook.com> and following the instructions to open an account. All terms and conditions of each social media platform apply. If you opt to use any social media platforms via your wireless mobile device, standard text messaging and/or data rates may apply. Your social media account(s) must be set to “public” (i.e., an account where anyone can view or subscribe to your photos). You must use only one social media account and identity to participate.

#### **4. RANDOM DRAWING, PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

**A. Random Drawing and Prizes:** On or about February 18, 2021 at 12:00:00 PM ET, Sponsor will select the potential winner from among all eligible entries received during the respective Entry Periods. The drawing will take place at an office of the Sponsor.

i. **Description:** The prize is a 6-day/7-night stay at Holiday Inn Club Vacations New Orleans Resort.

ii. **ARV:** The ARV of the prize available in this Sweepstakes is approximately \$1754 (based on a standard 2 bedroom/2 bath villa).

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
