

Terms & Conditions for UOB Credit Card Singtel Voucher Promotion ("Promotion")

- The Promotion is valid from 1 October 2021 to 7 October 2021 (both dates inclusive) ("Promotion Period"). By participating in this Promotion, you are deemed to agree to be bound by the terms and conditions of this Promotion (the "Terms").
- 2. This Promotion is only open to individuals who are new-to-UOB credit cardholders.
- 3. To participate in this Promotion, you must satisfy all of the following conditions:
 - (a) you must successfully submit an online application for a new personal credit card issued by United Overseas Bank Limited ("UOB") in Singapore (but excluding the Visa Infinite Metal, UOB Privilege Banking Card, UOB Reserve Card and UOB Professional Platinum Cards) as a principal credit cardholder ("Principal Credit Card") during the Promotion Period (the "Application");
 - (b) your Application must be approved by UOB by 31 October 2021; and
 - (c) you must activate your Principal Credit Card issued pursuant to your Application and charge at least S\$1,500 worth of Eligible Transactions (as defined below) to your Principal Credit Card within 30 days from your Principal Credit Card approval date (the "Qualifying Spend").
- 4. UOB has the right at its discretion to approve or decline any Application and is neither obliged to give any reason or prior notice on any matter concerning the Application nor be liable to any party.
- 5. If you are amongst the first 15 participants of this Promotion to satisfy all of the conditions in Clause 3 above, you shall be eligible to receive one Singtel voucher in the form of a promo code worth S\$1,299 (the "Gift").

If you qualify to receive a Gift under this Promotion, you shall not be eligible to participate in any other promotion or receive any other gift(s) from UOB in connection with your Application (including but not limited to the UOB Credit Card Cash Oct 2021 Promotion). For avoidance of doubt, if you do **not** qualify to receive a Gift under this Promotion, you will still be eligible for the **UOB Credit Card Cash Oct 2021 Promotion**.

- 6. For the purposes of this Promotion:
 - (a) "Eligible Transactions" shall mean any retail transactions for the purchase of goods and/or services successfully charged to your Principal Credit Card and which are posted on UOB's systems but excluding the Excluded Transactions (as defined below). For the avoidance of doubt, Eligible Transactions made in foreign currencies will be converted into Singapore dollars based on UOB's then prevailing exchange rate applicable at the time of exchange. The transaction amount posted in your Principal Credit Card account will be used for the purposes of computing the Qualifying Spend amount for this Promotion.
 - (b) "Excluded Transactions" shall mean:
 - (i) Any bill payment transactions to utilities or telecommunication providers;
 - (ii) Any cash advances, balance and/or funds transfers, instalment payments; personal loans;
 - (iii) SmartPay transactions;
 - (iv) SMART\$ transactions;
 - (v) Any payment of fees and charges (including but not limited to annual fees, administrative fees, interest charges, finance charges and/or late payment fees);

- (vi) Any amount charged that is subsequently cancelled, voided or reversed for any reason;

- 7. For the avoidance of doubt, if you apply for more than one Principal Credit Card in a single Application submitted pursuant to Clause 3 above and your Application for those Principal Credit Cards are approved by UOB at the same time during the Promotion Period; the amount of Eligible Transactions successfully charged to each such Principal Credit Card will be aggregated for the purposes of computing the Qualifying Spend pursuant to Clause 3 above.
- 8. If you are eligible to receive a Gift, you will be notified via SMS by 28 February 2022 (or such other date as UOB may determine in its sole discretion) based on your contact details in UOB's records (the "Redemption Notification");
- 9. The Redemption Notification set out details on the redemption of your Singtel voucher. UOB reserves the right to decline any redemption of the Singtel voucher if any one of the requirements set out in the Redemption Notification is not met at the time of redemption. No replacement will be issued for a lost, stolen or destroyed Redemption Notification. The Singtel voucher must be redeemed during the redemption period specified in the Redemption Notification. UOB will not extend the redemption period for any reason whatsoever.
- 10. The Cash Credit may only be used to offset your subsequent Principal Credit Card account bill.
- 11. The Gifts are not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost or stolen. No reservation, refund or exchange of the Gifts are allowed.
- 12. Gifts are on a first-come-first-served basis, whilst stocks last and subject to availability. UOB shall not be required to notify and/or update on the stock availability of the Gifts.
- 13. UOB may substitute any of the Gifts with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 14. You are only entitled to redeem one Gift under this Promotion, regardless of the number of UOB credit cards applied for under this Promotion.
- 15. Where applicable, the Gifts are supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of any of the Gifts. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Gifts and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Gifts. Any dispute regarding the Gifts are to be resolved directly with the merchant and/or supplier of the Gifts. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or

- supplier of the Gifts. For the purposes of this clause, "Gifts" includes any products and/or services provided by third party merchants in connection with the use and/or redemption of the Gifts.
- 16. UOB may at its discretion forfeit the Gifts, or, if already awarded, reclaim the Gifts at your expense (whether by deducting any of your UOB account(s) or otherwise) without payment, compensation, or having to give any reason whatsoever if your Principal Credit Card account applied for under this Promotion is closed or terminated within nine (9) months from the date such account was opened.
- 17. The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals who have cancelled their principal UOB credit card(s) six (6) months prior to the commencement of the Promotion Period:
 - (b) individuals who are existing principal holders of a UOB credit card at the time when their Application is approved;
 - (c) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (d) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (e) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (f) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 18. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Gifts or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction, howsoever caused.
- 19. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 20. Without prejudice to any of the other provisions in these Terms, if UOB determines that you are ineligible to participate in this Promotion or to receive the Gift, UOB may in its sole discretion forfeit the Gift, reclaim the Gift or charge to and debit an amount equal to the value of the Gift from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the Gift through such means as UOB may determine in its sole discretion.
- 21. The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 22. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 23. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.

- 24. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for all purposes in connection with this Promotion and to contact you, including by voice call or text message.
- 25. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce the Terms.
- 26. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
