Terms & Conditions for March One Card Sign Up Promotion from 1 March 2022 to 31 March 2022

- This Promotion is valid from 1 March 2022 to 31 March 2022 (both dates inclusive) ("Promotion Period"). By participating in this Promotion, you are deemed to agree to be bound by the terms and conditions of this Promotion (the "Terms").
- 2. This Promotion is only open to individuals who are **not** existing principal holders of any UOB Credit Card at the time when their Application is approved and have **not** cancelled any UOB Credit Card as a principal cardholder six (6) months prior to the commencement of the Promotion Period.
