

Terms and Conditions Governing the DBS Takashimaya American Express® Credit Card – S\$200 Cashback Acquisition Promotion ("Promotion")

- 1. Promotion is valid from 1 July 2021 to 30 September 2021 ("Promotion Period").
- 2. To qualify for the Promotion, customers ("Eligible Cardmembers") must:
 - i. not hold any existing DBS Takashimaya Card; and
 - ii. not have cancelled any DBS Takashimaya Card(s) within the last12 months; and
 - iii. apply <u>online</u> for a DBS Takashimaya American Express® Credit Card ("Card"), and Card must be approved during the Promotion Period; and
 - iv. fulfil the following spend criteria to receive the corresponding sign-upGift ("Gift"):

Qualifying Spend	Spend a minimum of S\$200 at Takashimaya Department Store within the first month from Card
requirement	approval date ("Qualifying Spend").
	For example, card approval date is on 10 July 2021, qualifying spend period will be from 10 July 2021 to 9 August 2021.
Promotion award	S\$200 Cashback ("Gift")



- 3. The Gift will be credited to the Eligible Cardmember Card account by the end of 90 days from Card open month.
- 4. The Qualifying Spend can be an accumulative spending and must be made at Takashimaya Department Store and/or Takashimaya Department Store's online store, in Singapore.
- 5. Qualifying spend excludes
 - purchase of Takashimaya Gift Vouchers
 - transactions at Cold Storage, Food Village and selected food merchants at Food Hall, B2
 - transactions on instalment payment plan and My Preferred Payment Plans
- 6. Any transaction reversal will be considered when computing the Qualifying Spend.
- 7. DBS will not account for any failure of delay in posting of sales transactions which may result in any customer being omitted from enjoying the benefits of this Promotion.
- 8. Supplementary Cardmembers are not eligible to participate in the Promotion. However, Supplementary Card spend can be included in the calculation of Qualifying Spend.
- 9. Each Qualified Cardmember is limited to one Gift during the Promotion Period. The Gift is strictly non-redeemable for cash, non-transferable, non-assignable, non-exchangeable and non-replaceable.
- 10. DBS reserves the right to substitute or replace the Gift with another gift of similar value without giving any prior notice or liability to any party.
