

Terms and Conditions (“Terms and Conditions”) for “Receive S\$50 plus 1% Cashback Cashline Promotion” (“Promotion”)

1. Promotion is available from 1 March 2021 to 31 December 2021 (“Promotion Period”).
2. Successful applicants (“applicants”) will receive the following cashback amount (“Cashback”), if the following conditions are satisfied within the Promotion Period:

Tier 1: S\$50 Cashback

- Successfully applied for a Cashline account (“Cashline”)

Tier 2: 1% Cashback on Outstanding Balance

- Successfully applied for a Cashline and accumulate **minimum S\$10,000 closing balance** in either of the first two statement months, whichever higher.

Conditions:

- (a) Application must be made via self-apply online application platform.
- (b) Must not hold an existing Cashline.
- (c) Must not have any cancelled Cashline within the last 6 months from date of application.
- (d) The accumulated closing balance of minimum S\$10,000 must be reflected as Closing Balance as of statement date (in a single month statement) in order to be eligible for the Cashback.
- (e) In the event minimum of S\$10,000 closing balance is accumulated in first two consecutive months, Cashback will only be awarded to the statement month with higher balance.
