

## **Terms and Conditions for DBS/POSB Credit Card Sign-Up Flash Deal x SingSaver Promotion (“Promotion”)**

1. The Promotion is valid from 2 May 2025 till 18 May 2025 (“**Promotion Period**”).
2. The Promotion is applicable to customers who are currently not holding on to any Principal DBS/POSB Credit Card and have not cancelled any Principal DBS/POSB Credit Card within the last 12 months (“**Eligible Customer(s)**”).
3. To qualify for the Promotion, Eligible Customers must fulfil the following qualifying criteria below to receive one of the welcome gifts (“**Welcome Gift(s)**”):
  - a. Apply for an eligible Principal DBS/POSB Credit Card (“**Eligible Card(s)**”) online with promo code of the selected Welcome Gift:

- b. Have the Eligible Card applied within the Promotion Period and approved by 1 Jun 2025; and
  - c. Charge a minimum spend of S\$500 to the approved Eligible Card within the first 30 days from the date of Card approval (“**Qualifying Spend**”).
4. If the Eligible Customers have fulfilled all the criteria under Clause 3 (“**Eligible Cardmember(s)**”), Eligible Cardmembers will receive an email from DBS with details on how to redeem the Welcome Gift (“**Welcome Gift Notification Email**”) and a push notification reminder via digibank app (if the notification service is enabled) within 4 months after meeting the Qualifying Spend.
  - a. Eligible Cardmembers are encouraged to check their spam, junk, updates, or promotion email folders for the Welcome Gift Notification Email as there may be accidental redirects in your mailbox.
  - b. Where the selected Welcome Gift is Nintendo Switch OLED, Apple iPad (A16) 11” WiFi 128GB or Apple AirPods Pro (Gen 2) with MagSafe Charging Case + MagSafe Charger:
    - i. Eligible Cardmembers will be able to claim their Welcome Gift from the designated redemption centre of SingSaver Pte. Ltd (“**SingSaver**”) as set out in the Welcome Gift Notification Email; and

    - d. any top-ups or payment of funds to payment service providers, any prepaid accounts or purchase of prepaid cards/credits (including but not limited to EZ-Link, GrabPay, NETS FlashPay, Transit Link, Razer Pay, ShopeePay, Singtel Dash, Amaze);
