### Frequently Asked Questions

#### How do I get my Stock Cash Coupon?

1. Open your FUTU SG securities account as soon as possible! It takes 1-2 business days for the approval process.
2. After your FUTU SG securities account has been successfully opened, make your first successful deposit of SGD 2,700 or USD 2,000 or HKD 16,000 into your account by 1 November 09:59 SGT. It takes about 15 minutes if you are using Instant Deposit via DDA, or 1-3 business days if you are using bank transfer!
3. Once your first deposit is successfully settled into your FUTU SG securities account, you will receive your Stock Cash Coupon(s) in your “Coupons” page within 1 business day!

## I opened an FUTU SG securities account before the campaign period but have not deposited. Am I still eligible for this campaign?

Existing users who successfully opened a FUTU SG Securities Account and did not successfully deposit any amount into their FUTU SG securities account before 19:59 SGT on 2 October 2021 will receive only Treasure Box No. 2, where the treasure box will also be bound by the same terms and expiry.

## Can I deposit in other currencies instead?

You can choose to deposit SGD 2,700 or USD 2,000 or HKD 16,000 into your securities account.

## How will the rewards be credited to me?

Users will need to download the moomoo mobile app on either Apple App Store or Google Play Store and log in to receive the rewards after completing the respective missions.
