



## Moneymax Car Insurance Lucky Draw Exclusive Campaign Terms & Conditions

1. The **Moneymax Car Insurance Lucky Draw Exclusive Campaign** (hereinafter referred to as “**Campaign**”) is organized by MoneyGuru Philippines Corporation [CS20141415] for [www.moneymax.ph](http://www.moneymax.ph) (hereinafter referred to as “**Moneymax**” or “**we**”).

### Campaign Period

2. The Campaign comprises of the following periods:
  - a. “**Lucky Draw Period**” runs from **April 18, 2024** to **May 14, 2024**, both dates inclusive;
  - b. Deadline for submission of entries is on **May 14, 2024, 11:59 PM** ;
  - c. Lucky Draw date is on **May 17, 2024**.

### Campaign Eligibility

3. The Campaign is open to individuals who:
  - a. are 21 years old and above; and
  - b. are a resident of the Philippines (including Filipinos, Permanent Residents, work pass holders or international students);
  - c. own a car under the individual’s name and the individual has a document to prove ownership and the car is located in the Philippines.
  - d. submit the entry form for the Campaign on the Moneymax Website (“**Lucky Draw Form**”) to Moneymax in accordance with Clause 4 below during the Lucky Draw Period, based on Moneymax’s internal records; and
  - e. be contactable via the email address and Philippine phone number provided to Moneymax, i.e by providing a valid Philippine phone number which starts with +63, and a valid email address.
  - f. submit valid proof of car ownership either by providing their official receipt or certificate of registration.
  - g. Moneymax reserves the right to disqualify any participant from participating in this Lucky Draw if the participant does not fall into one of the above categories.
4. Entry Requirements:
  - a. To participate in the Campaign, participants must, during the Lucky Draw Period, enter their details and answer all fields on the form available at [[www.moneymax.ph/insurance/ci-mmx-iphone-promo](http://www.moneymax.ph/insurance/ci-mmx-iphone-promo)] (the “**Lucky Draw Form**”) and ensure that:
    - i. all fields of the Lucky Draw Form are completed; and
    - ii. a valid phone number and email address is provided in the Lucky Draw Form
    - iii. The Lucky Draw Form is successfully submitted to Moneymax, based on Moneymax’s internal records.



- b. Participants who do not fulfil the requirements set out in Clause 3 above will not be eligible to participate in this Campaign, even if they submit a Lucky Draw Form in accordance with this Clause 4.
5. Moneymax reserves the right to reject information submitted on the Moneymax website and/or social media if we deem it not legible, in non-English alphabets, to use foul language, or as spam or of an incorrect or fraudulent nature.

### Campaign Mechanics

6. All participants who fulfil the Campaign Eligibility requirements set out in clauses 3-4, and their subclauses above, will be considered **"Eligible Participants"** of the Campaign.
7. Each Eligible Participant who submits a Lucky Draw Form in accordance with the terms set out herein will have a maximum of one (1) entry to the Lucky Draw.
8. Each Eligible Participant will be entitled to a single entry into a lucky draw which will be conducted by Random.org (**"Lucky Draw"**). The winner will be selected randomly, through an electronic raffle draw via Random.org's Third-Party Draw Service, up to a maximum of one (1) winner, on 17th of May 2024 at 3:00PM PHT and the selected winner will be considered as a **"Lucky Draw Winner"**. The raffle draw will be conducted with the supervision of a representative from the Department of Trade & Industry (DTI).
9. The Lucky Draw Winner is entitled to receive an iPhone 15 Pro Max 256GB worth **PHP 91,990** (the **"Lucky Draw Gift"**). The Lucky Draw Winner will be entitled to receive one (1) Lucky Draw Gift only. Moneymax's selection of the Lucky Draw Winner will be final.

  - a. The submission of a Lucky Draw Form does not automatically entitle an Eligible Participant to receive a Lucky Draw Gift.

### Lucky Draw Redemption

7. Moneymax will announce the Winner on its Facebook page (<https://www.facebook.com/moneymax.ph>) and will



contact the Lucky Draw Winner on or before **May 20, 2024 (“Raffle Announcement”)**:

- a. via email (email address in Moneymax’s record); and/or
- b. via SMS (mobile phone number in Moneymax’s record).

8. Lucky Draw Winner will be contacted via registered mail and email with details on how to redeem the Lucky Draw Gift within three (3) business days after the date of the Raffle Announcement (“**Notification Email**”). Lucky Draw Winner is encouraged to check spam/junk folders for the Notification Email as there may be accidental redirects by the email client.

9. Lucky Draw Winner may claim their Lucky Draw Gift at 6/F, ACT Tower, Salcedo Village, 135, H.V. Dela Costa, Makati City 1200 Metro Manila. In the event that a Lucky Draw Winner is residing in a provincial area, the Lucky Draw Gift will be delivered to the address supplied by the Lucky Draw Winner to Moneymax (“**Winner Address**”). Delivery or fulfilment of Lucky Draw Gift is estimated to be seven (7) to ten (10) days from date of Notification Email. - a.
