



Terms & Conditions - The Edit – Registration Prize Draw (the “Promotion”)

Eligibility

1. This Promotion is open to teachers:
 - a. have an active Sky Up account and have registered for The Edit
 - b. are residents of the UK and Republic of Ireland; and
 - c. aged 18 years or over (proof of age may be required).

2. The following categories of entrant are not permitted to enter this Promotion:
 - a. Employees of Sky UK Limited or any associated companies (“**Sky**”)
 - b. Employees of companies associated with the Promotion and all affiliates of such companies.

Entry Period

3. This Promotion opens at 12:00 on Monday the 20th of January 2025 and closes at 12:00 on Friday 28th of February 2025 (the “**Promotional Period**”).

Entry Requirements

4. Online entry required. To enter this Promotion, all you need to do is

 - then click ‘register account’
 - Click ‘Take part’ on The Edit
 - Complete drop down ‘How did you hear about us’
 - Input the number of students you plan to run The Edit with in the ‘How many students do you plan to run the edit with’ section
 - Click ‘Click here to start’

5. One entry per teacher.

6. Entries sent in through agents, third parties, websites or multiple accounts will be disqualified. Late, incomplete or otherwise ineligible entries will also be disqualified. Promotion of Entries through third party websites other than the host website is prohibited.

Winner Selection and notification

7. Two winners will be selected at random by a random computer-generated draw. The winners will be chosen based on the following criteria: registered for The Edit year 5 on or around Monday 3rd



March 2025 from all eligible entries received during the Promotional Period. The winners will be notified by email by Friday 7th March 2025.
