ENTRANTS

3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS. NO PURCHASE NECESSARY.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. Invitation for this event is based on rated play.

KIOSK GAME CONDUCT

1. On each kiosk game date of the Promotion, guests will be able to receive one play for every \$2 SLOT DOLLARS® earned each day, up to ten (10) times per day. Guest may only earn plays for that gaming day. SLOT DOLLARS® and games cannot roll over to the next day.

2. Wednesdays in October will offer complimentary plays for eligible MGM Rewards Members based on tier. Each Wednesday in October, qualified Sapphire and Pearl members receive 1 complimentary kiosk game play; all Gold members receive 1 complimentary kiosk game play; all Platinum members receive 2 complimentary kiosk game plays, all NOIR members receive 3 complimentary kiosk game plays.

3. Guest will play the kiosk game by swiping their MGM Rewards card and entering their PIN at any promotional kiosk. Prizes in the kiosk game include Las Vegas trips, sporting event tickets, merchandise, *FREEPLAY*®, entries to the flagship drawings, and SLOT DOLLARS®.

4. Guest may choose to receive an alternate prize of \$500 *FREEPLAY*® voucher in lieu of Las Vegas trip prize.

5. Guest may choose to redeem 3 t-shirt/hat tickets for a \$15 *FREEPLAY*® voucher at the MGM Rewards desk.

6. Guest may choose to receive an alternate prize of \$300 *FREEPLAY*® voucher in lieu of Sporting Event prize.

7. MGM Rewards Members can earn Rewards SLOT DOLLARS® by inserting their MGM Rewards Card into any functioning video gaming machine and registering play.

8. Guests that receive merchandise prizes or *FREEPLAY*® value of more than \$300 will be required to verify identity. For Kiosk game winners, a receipt will direct winner to the MGM Rewards desk to redeem. Valid identification will be required.

a. If promotional kiosks are unavailable, prizes may be issued via alternate methods or in extended periods. Effected winners may receive information on claiming prizes via traditional advertising methods.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.

21. Falsification of any information will result in ineligibility to claim any prize.
