## “For the Love Of Flushes”

### Four Flush Frenzy

1. You must be at least 21 years of age to participate. The Promotional funds from every game will be a max of \$2 with \$1 taken on the flop and \$1 taken at \$20 pot size. The Promotion rake taken from each game pot will be placed in a drop box on the opposite side of the table from the House rake. The Promotion rake Drop box will be collected and counted consistent with the internal control procedures of the MGM Grand Poker Room. One hundred percent (100%) of the daily Promotion rake will be posted to the Promotion reserve account daily. The Promotion reserve account will be used to fund the High Hand payouts and other promotions.
2. Only Texas Hold'em cash games are eligible for the Four Flush Frenzy Promotional payouts, bomb pots are excluded. Cash games that do not add to the Promotion rake and Daily Tournaments are excluded from all promotions funded by cash game Promotion rake.
3. The Four Flush Frenzy period will **begin Tuesdays @ 8:00am and end Wednesdays @ 8:00pm.**
4. Four Flush Frenzy Promotional stamp cards consist of (4) specific poker hands: Spade Flush, Heart Flush, Club Flush and Diamond Flush. To complete a Four Flush Frenzy card, a player must make flush in every suit.
5. Each player wishing to participate in the Four Flush Frenzy Promotion must receive a Four Flush Frenzy stamp card from the Floor Supervisor upon completion of the players first made flush.
6. If a player refuses to participate in Four Flush Frenzy and does not receive a card with their first stamp after completion of the first flush, they will not be eligible to receive a stamp later for a previously played hand.
  - a. **EX/ A player makes a heart flush and states they do not wish to participate. If the player makes a spade flush later in the day and asks for a flush card, they will receive a stamp ONLY for the spade flush. The heart flush would not be eligible for a stamp.**
7. Players will have 24 hours to fill out each flush card. The 24 hours will start upon completion of the first flush made. **Any Four Flush Frenzy card started between Tuesday @ 8:00am and Wednesday @ 8:00pm will have the full 24 hours to be completed.**
  - a. **EX/ Should a player receive a stamp for their first flush on Wednesday @ 7:58pm, that player's flush card will be "active" and eligible for completion until Thursday @ 7:58pm.**
8. Both player's hole cards must be suited to receive a stamp. However, players are not required to have the best 5 card combination to receive a stamp.
  - a. **EX/ A player holds 5h6h and the board reads 9s2h3hJhQh. The player holds two hearts but the 5h does not play as part of the best five card hand. The player would receive a stamp for making a flush on the turn. If a completed board has 5 cards of the same suit, the player with suited hole cards that match the board will still receive a stamp.**
9. To be eligible for a stamp, hands are required either go to showdown or be the last live hand after all other players have folded. For eligibility purposes, hands are considered complete once action is complete and the flush is tabled. Each flush must be verified by a Floor Supervisor.
  - a. **EX/ Players cannot fold when facing a bet and table their folded hand to receive a stamp. Dead hands will not receive a stamp.**
10. **Players with a completed Four Flush Frenzy card with all requirements met will receive \$400.**
11. Tuesdays and Wednesdays, the poker room will hold drawings at 7:30pm, 8:30pm, 9:30pm and 10:30pm for all eligible players defined in rule 13.



12. The minimum prize for each drawing will be \$100. Players with ACTIVE flush cards are eligible for higher drawing payouts:
  - a. **0-1 Stamps = \$100**
  - b. **2 Stamps = \$200**
  - c. **3 Stamps = \$300**
13. Eligible Players:
  - a. An Eligible Player is any player who is actively playing an Eligible Game.
    - i. Players that sit out of a hand will be placed in lobby immediately prior to the start of the next hand. EX/ When a player leaves their chair, the player will be placed in lobby exactly before the dealer begins a new shuffle. Guests are returned from lobby when they accept a hand when returning to the table. Any player in Lobby at the time of the drawing is not an Eligible Player and is not qualified to draw.
    - ii. Players logged in as “guests” will remain active and be an Eligible Player. These “guests” must create an MGM account to draw for a prize.
14. Eligible Games include any poker game for which a Promotional Fund contribution is collected to fund the Promotional Reserve Account.
  - a. Promotional Funds will be maximum \$2 drawn from the pot of each game, consisting of:
    - i. \$1 taken on the flop; and
    - ii. \$1 taken on a pot of at least \$20.
  - b. Eligible Games do not include cash games with no promotional draw nor games played as part of a Daily Tournament.
15. **Players are only permitted one active flush card.** When a player completes a flush card, they will be eligible for stamps on a second flush card. **Active flush cards must always remain on the table.** There is no minimum pot size requirement for a stamp. Flushes that meet all other requirements will qualify. Players are responsible for their own flush card. The poker room will keep a log of all active flush cards. The poker room will not re-issue or re-stamp a flush card to make up for a lost stamp or card.
16. Poker Room employees are eligible to participate.
17. Reduced rake games are eligible for promotions if a promotional fund is being taken and all other requirements are met.
18. Players have the option to not put promotional winnings on the table but can add any amount of the promotional winnings to their stack at the time of the receipt of chips. Chips not in play must be removed from the table. Chips are not in play until received from the MGM Grand Poker Room staff.
19. IRS regulations require U.S. citizens to present valid identification and a social security number.
20. For U.S. Citizens, Form 1099-MISC will be issued for all promotional winnings of \$600 or more. Non-resident aliens without a tax treaty are subject to 30% withholding on 100% of all promotional winnings of \$600 or more and will be issued a 1042-S. The decisions of MGM Grand management regarding all aspects of this promotion are final and binding, subject to NRS 463.362 which governs this promotion.
21. The MGM Grand reserves the right to modify or discontinue this promotion at any time.
